








#### 5. Did your firm increase or decrease pay or benefits in 2020? (mark all that apply) Responses: 32







7. Did an owner postpone or cancel any projects that were scheduled to start in 2020 or 2021? (mark all that apply) Responses: 31




8. When do you expect your firm's volume of business will return to its normal level relative to one year earlier? Responses: 32









