



Continuing Education Units (CEUs)

AGC of America is authorized by multiple organizations to offer Continuing Education Units (CEUs) and other professional development credits. AGC members and non-members throughout the design and construction industry are able to fulfill their credit requirements for license renewals and career development through AGC programs.

Most types of continuing education can be self-reported by individuals to the specific credentialing organization. AGC must provide a certificate of completion to each attendee who wants to receive credit, with the exception of AIA CES Learning Units which must be reported by AGC on attendees' behalf.

International Association for Continuing Education and Training (IACET)

AGC of America has been accredited as an Accredited Provider by the International Association for Continuing Education and Training (IACET). In obtaining this accreditation, AGC has demonstrated that it complies with the ANSI/IACET Standard which is recognized internationally as a standard of good practice. As a result of their Accredited Provider status, AGC is authorized to offer IACET CEUs for its programs that qualify under the ANSI/IACET Standard.

American Institute for Construction (AIC)

AGC of America is approved to offer Continuing Professional Development (CPD) credits for qualifying programs by the American Institute for Construction (AIC).

American Institute of Architects (AIA)

AGC of America is a Registered Provider with the American Institute of Architects Continuing Education Systems (CES). For qualifying programs, AGC reports credit earned to CES Records for AIA members and, upon request, will provide non-AIA members with a certificate of completion to use towards additional license renewals.

U.S. Green Building Council (USGBC)

In association with the U.S. Green Building Council (USGBC), the Green Building Certification Institute (GBCI) reviews and approves educational programs on a case-by-case basis. Upon approval, AGC of America offers GBCI Continuing Education hours for various curricula programs and conferences.

- **Audience** – LEED AP certified professionals
- **Type of Credit** – GBCI Continuing Education (CE) hours
- **Programs** – BIM Education Program, Lean Construction Education Program, Contractors Environmental Conference

National Association of State Boards of Accountancy (NASBA)

AGC of America is registered with the National Association of State Boards of Accountancy (NASBA) as a sponsor of continuing professional education on the National Registry of CPE Sponsors. State Boards of Accountancy have the final authority on the acceptance of individual courses for CPE credit.
