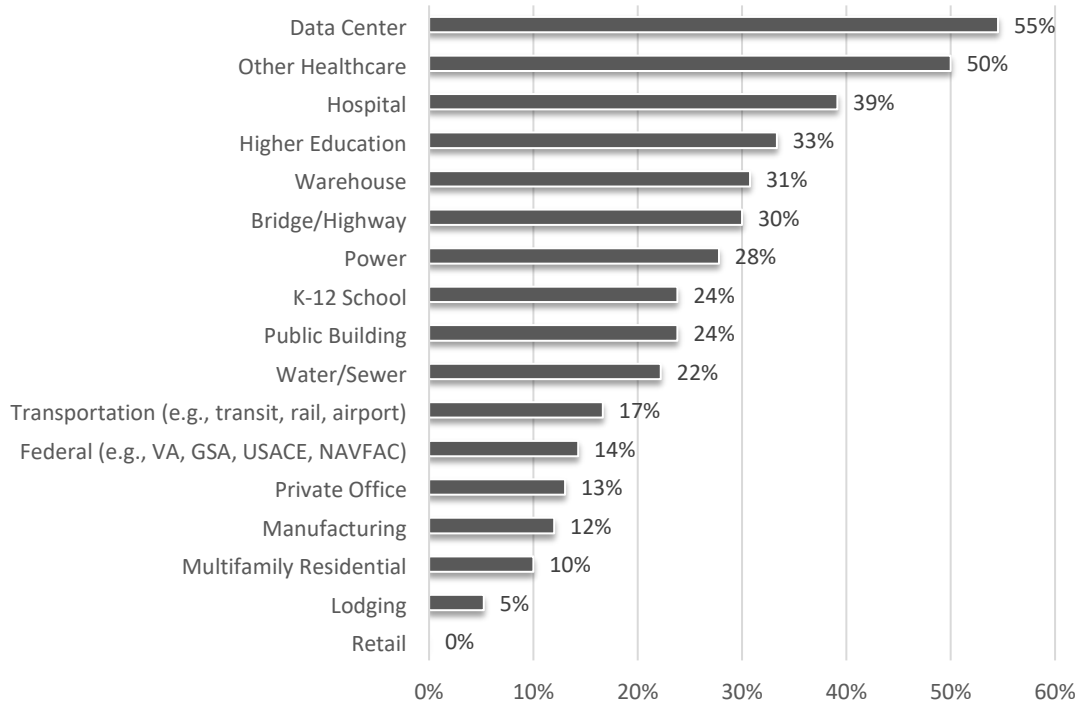

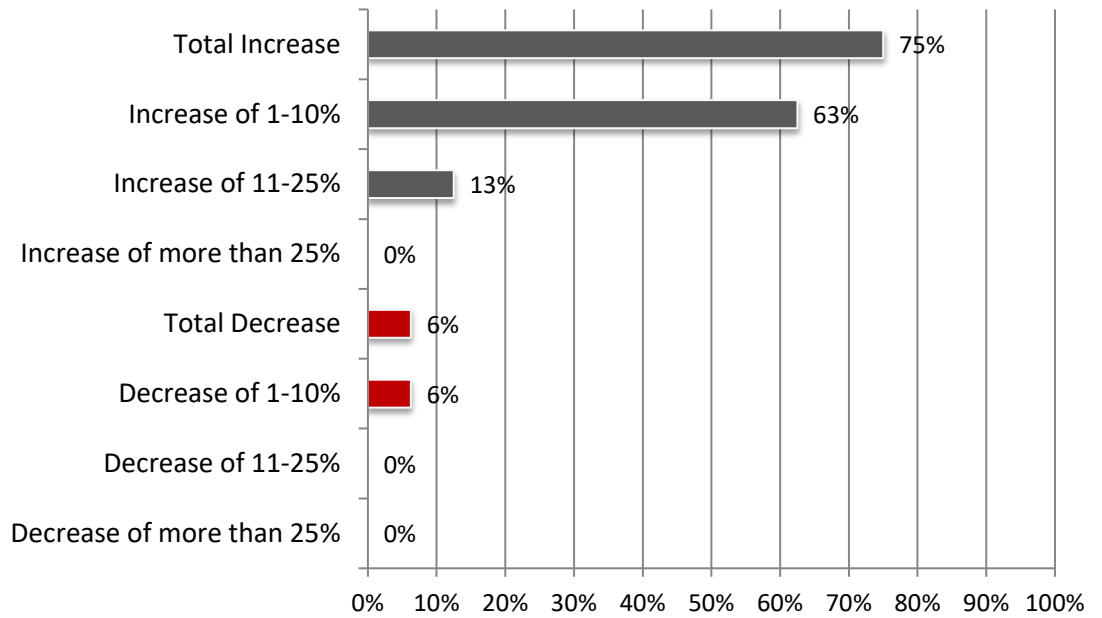

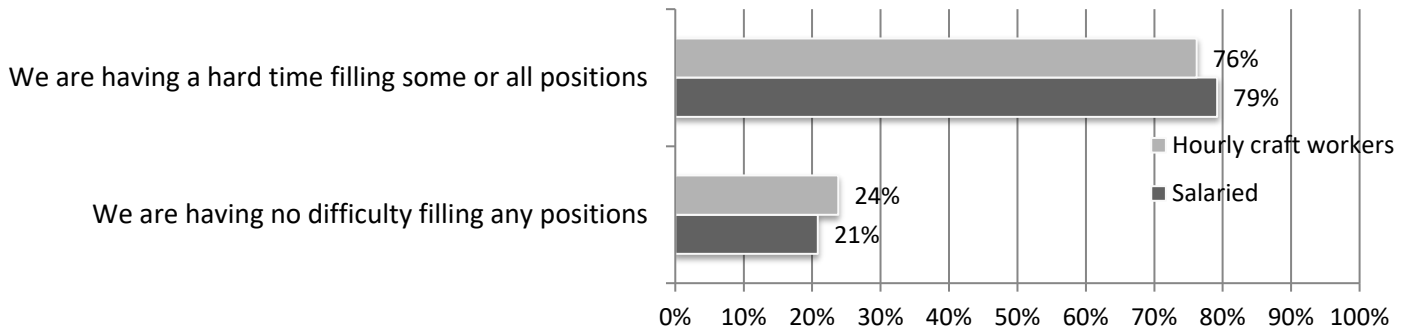

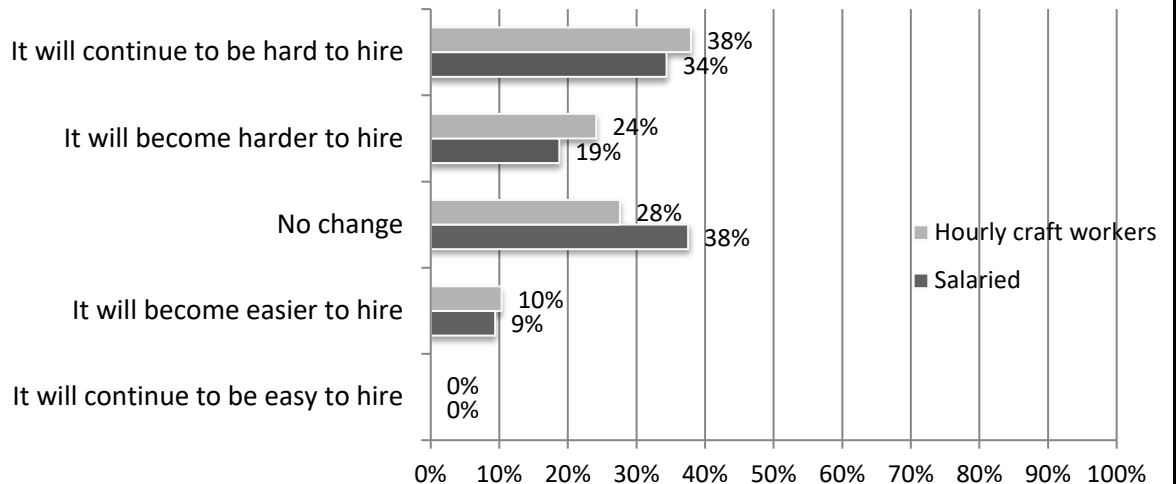

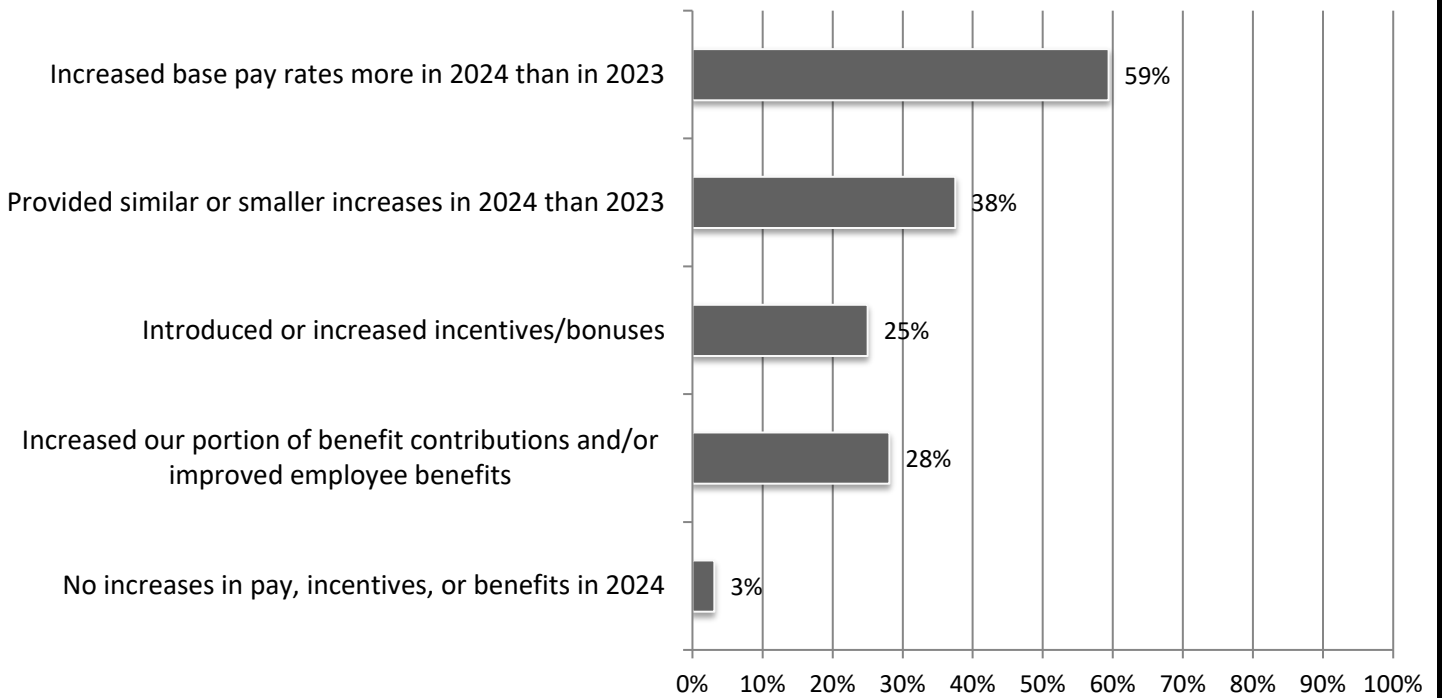

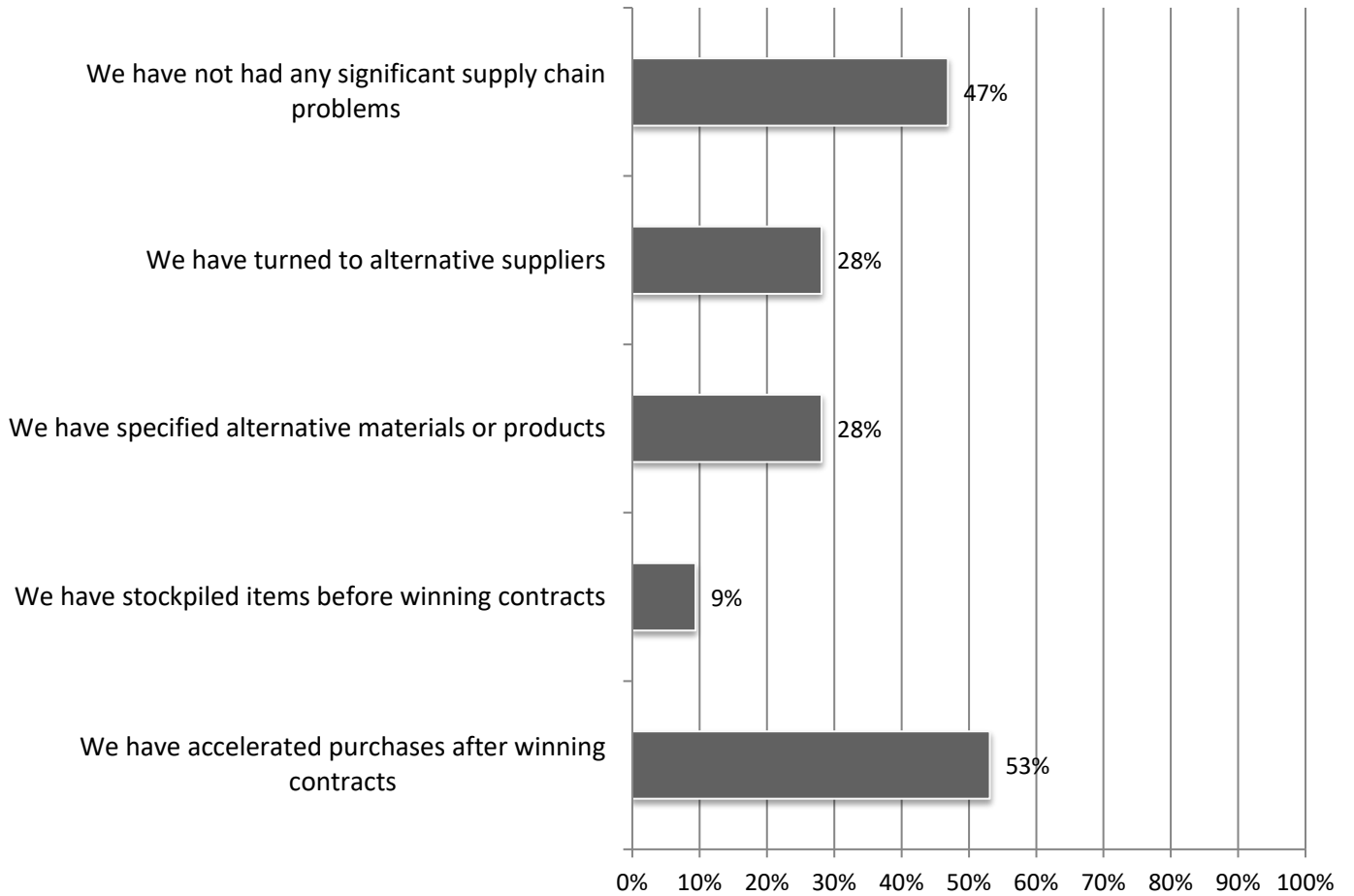
4. Do you expect any changes in the availability of hourly craft or salaried personnel over the coming 12 months? Responses: 32



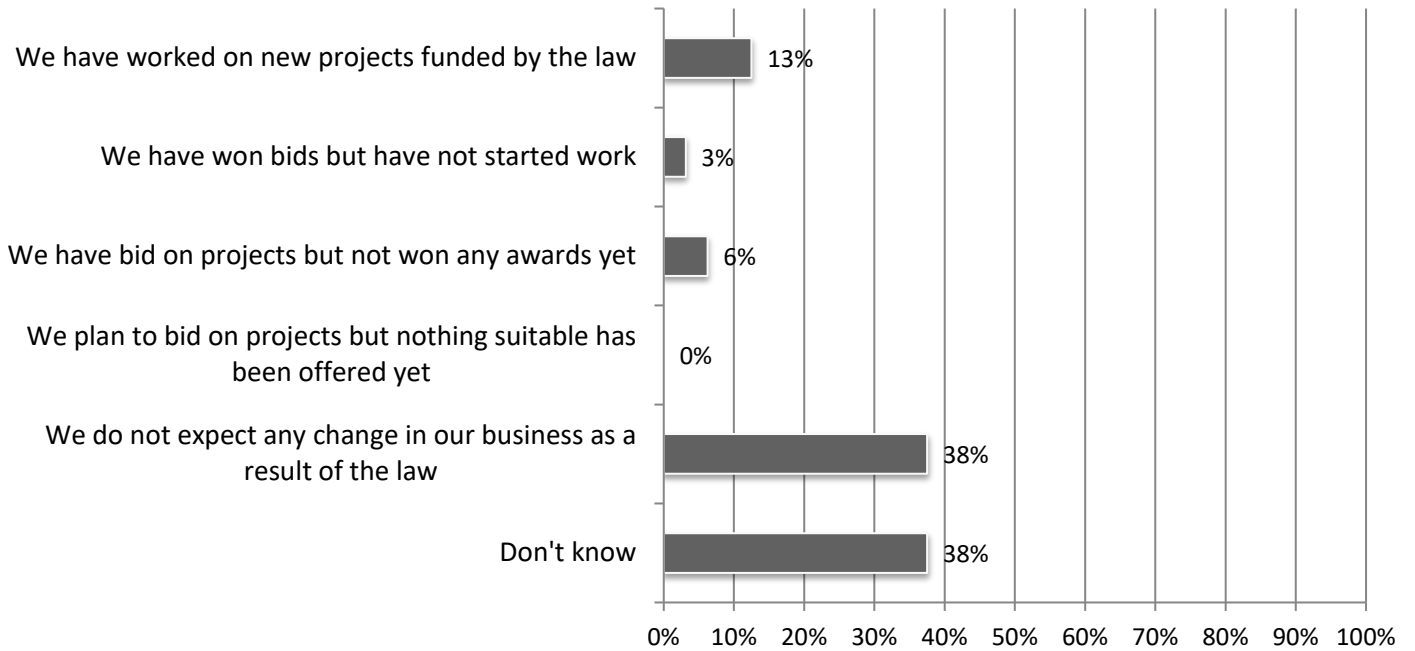
5. What changes did your firm make in pay or benefits in 2024? (mark all that apply) Responses: 32



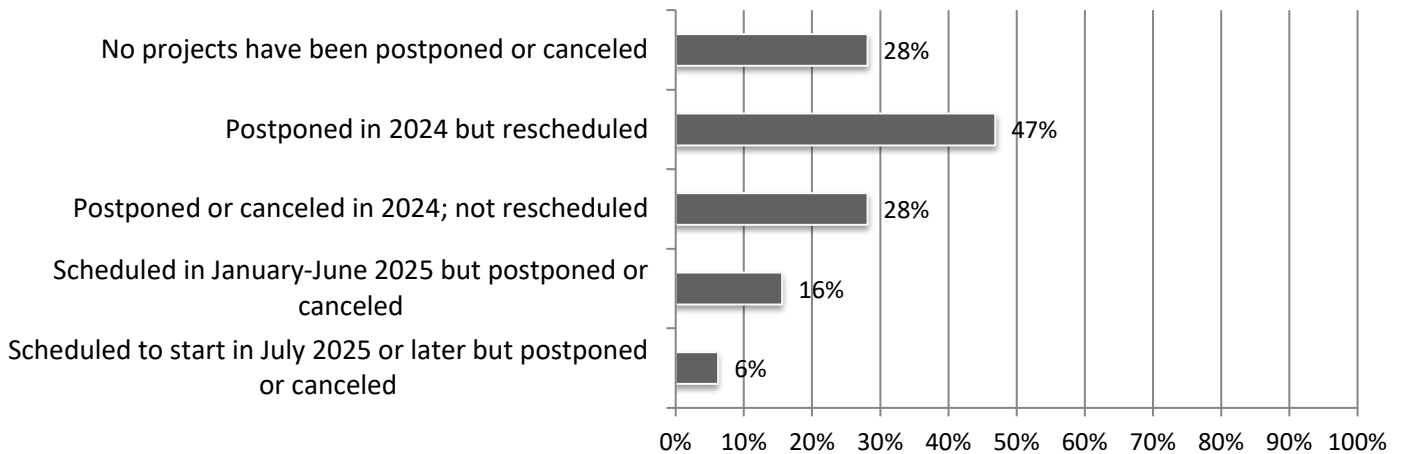

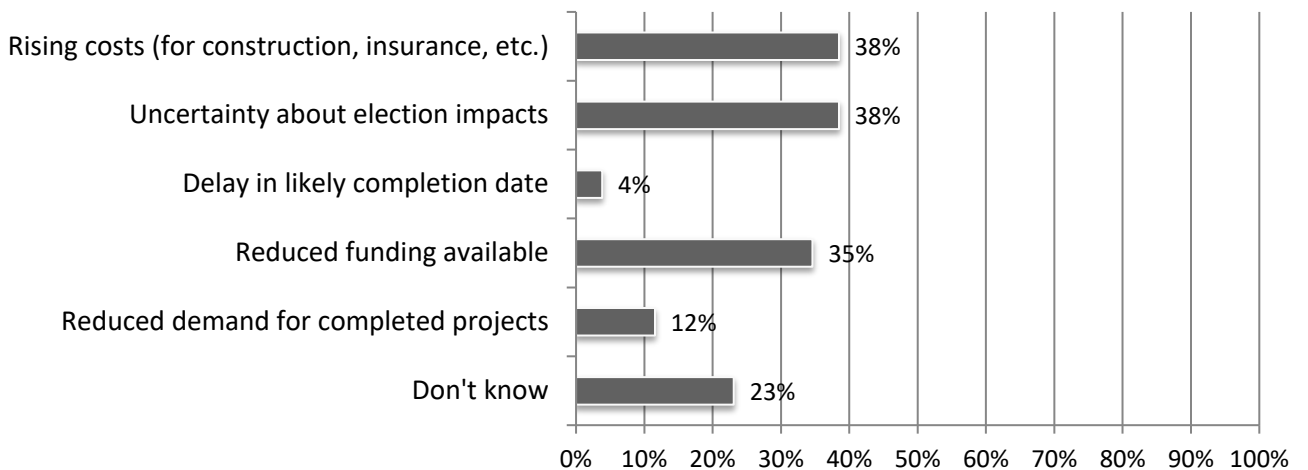

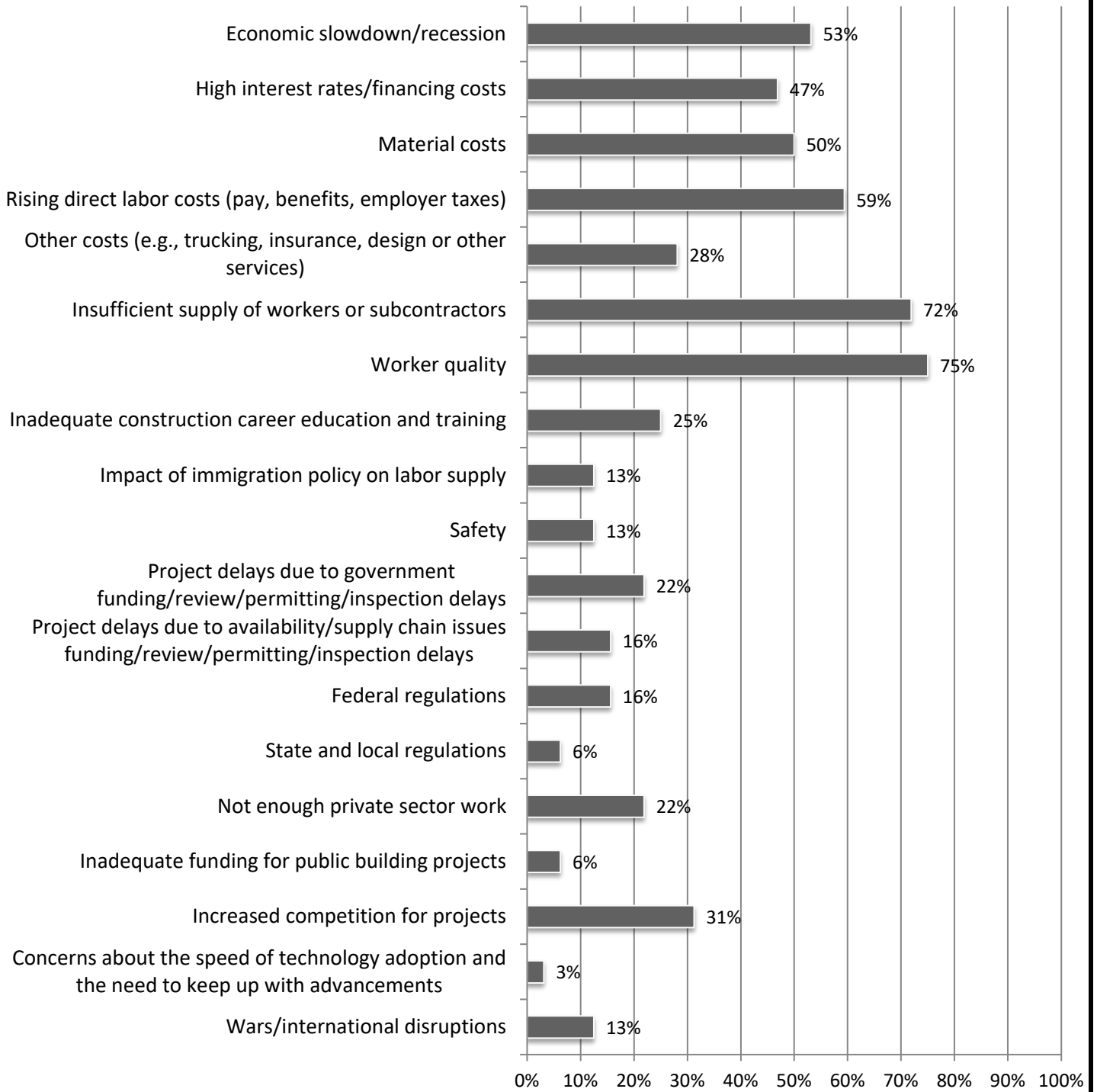

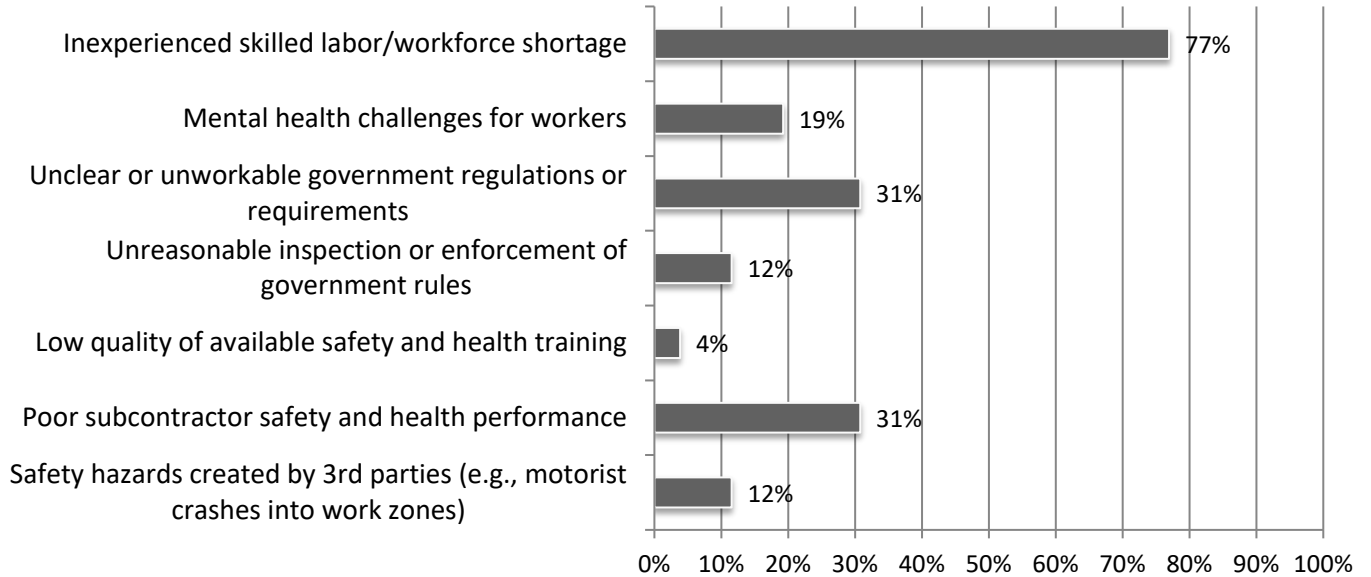

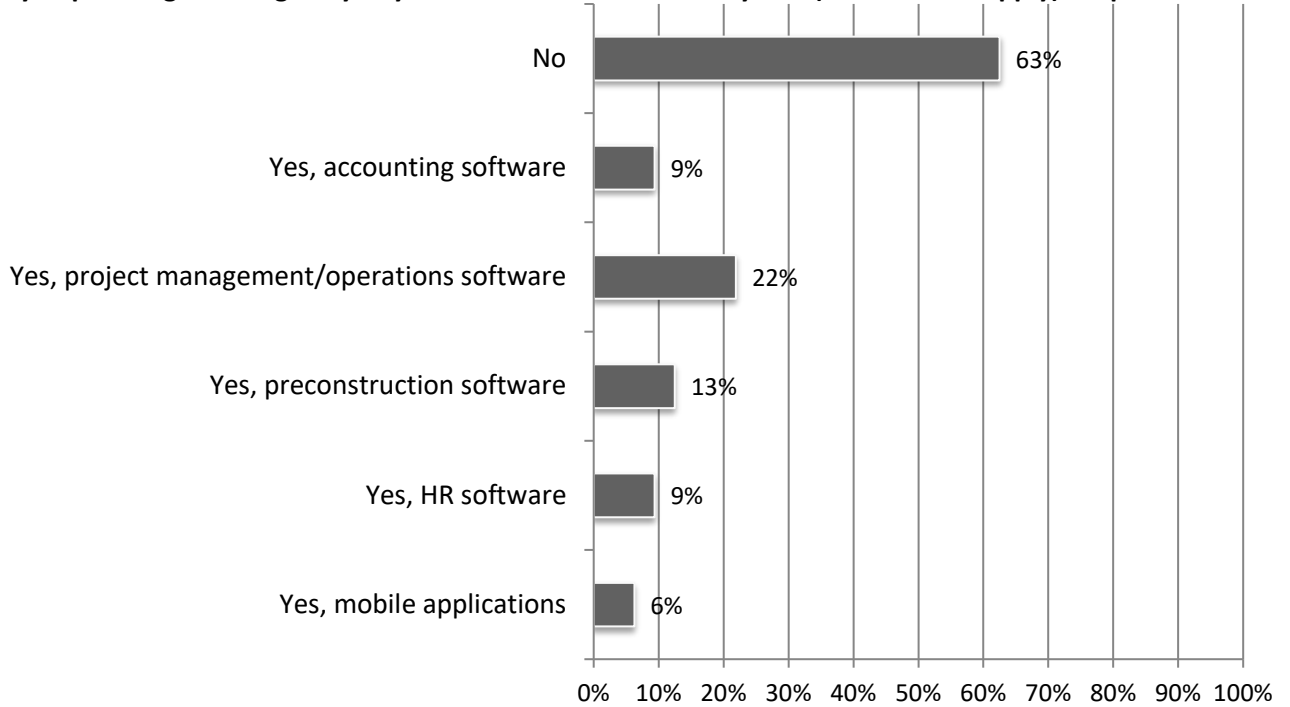

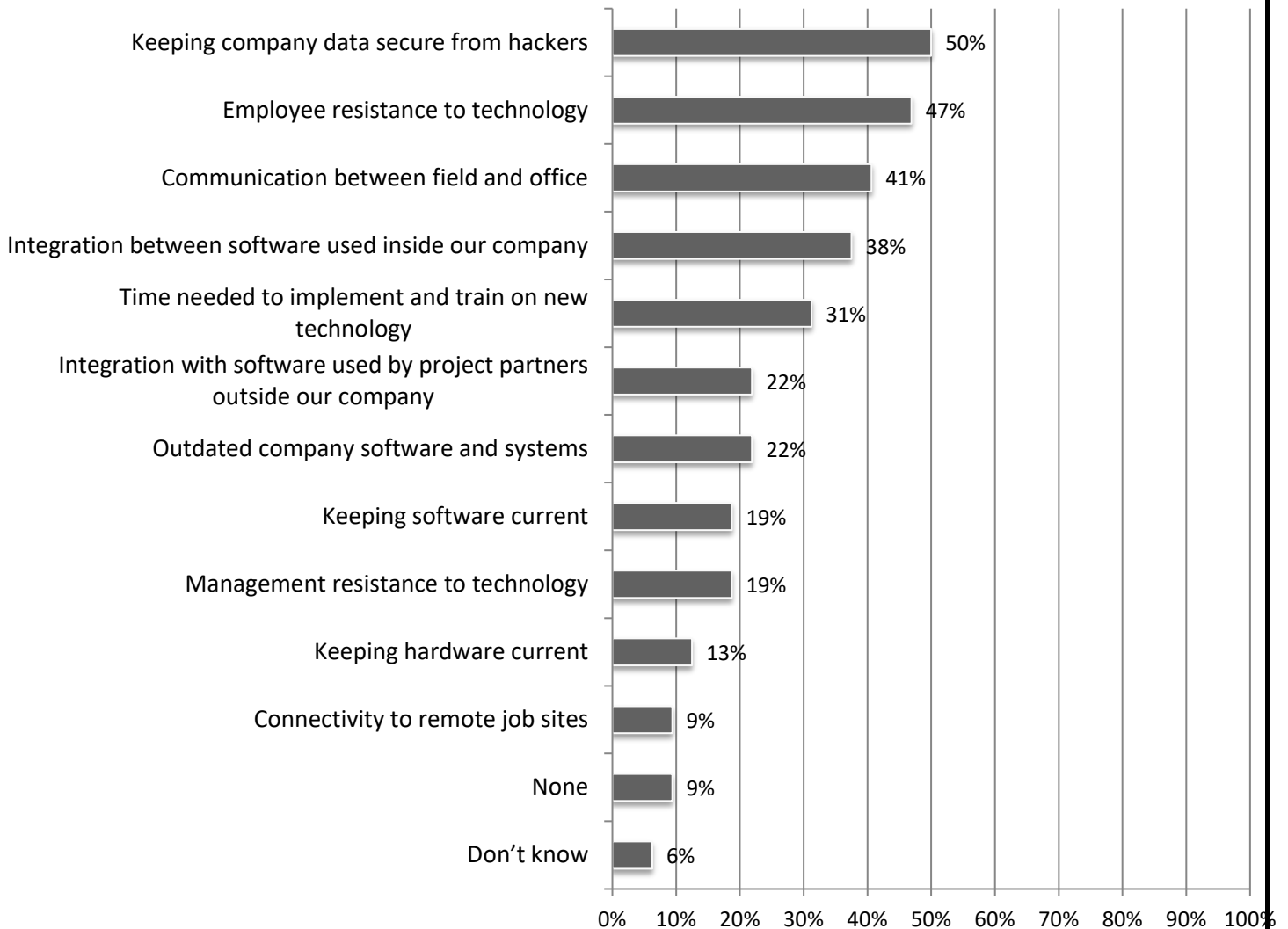

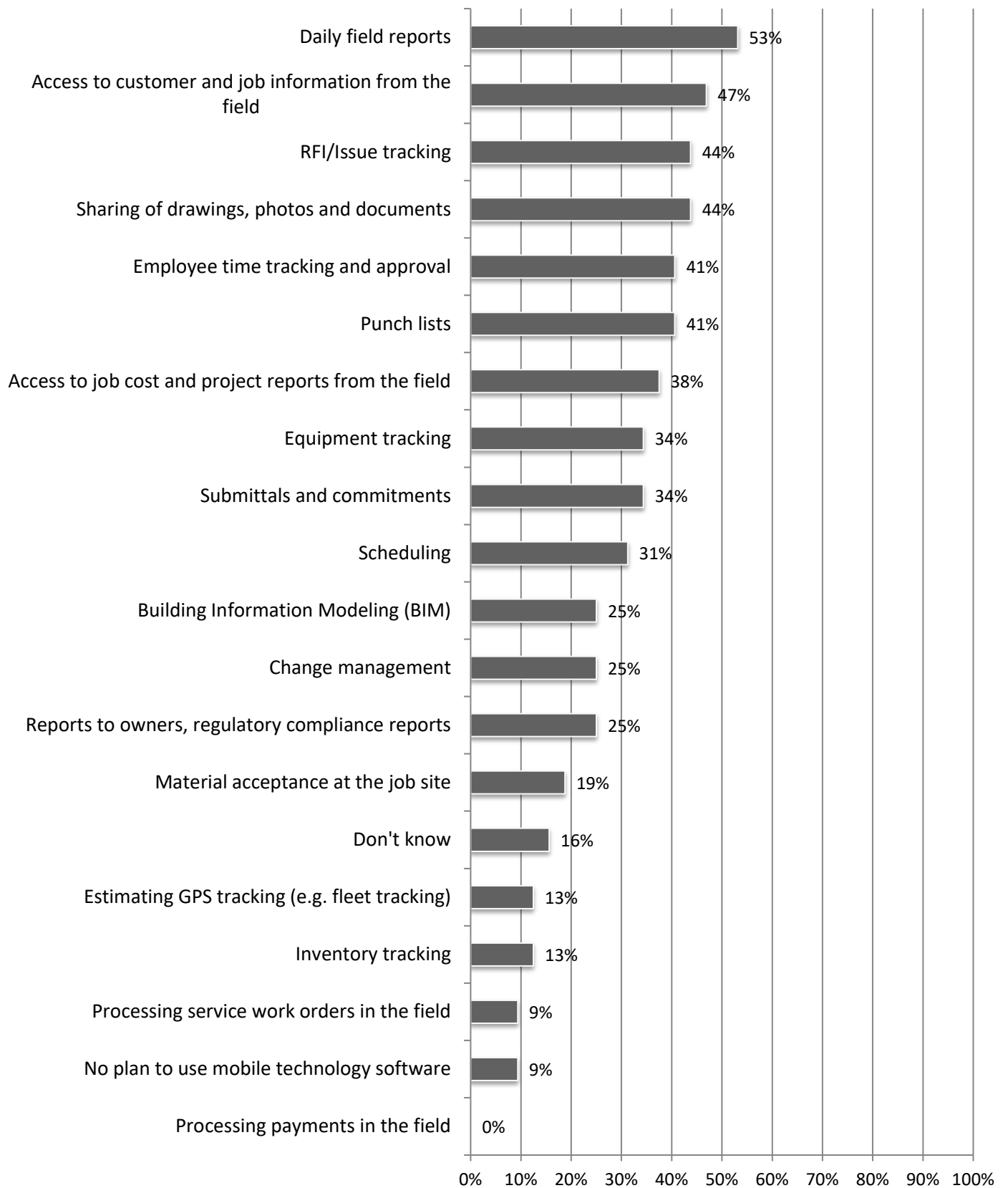

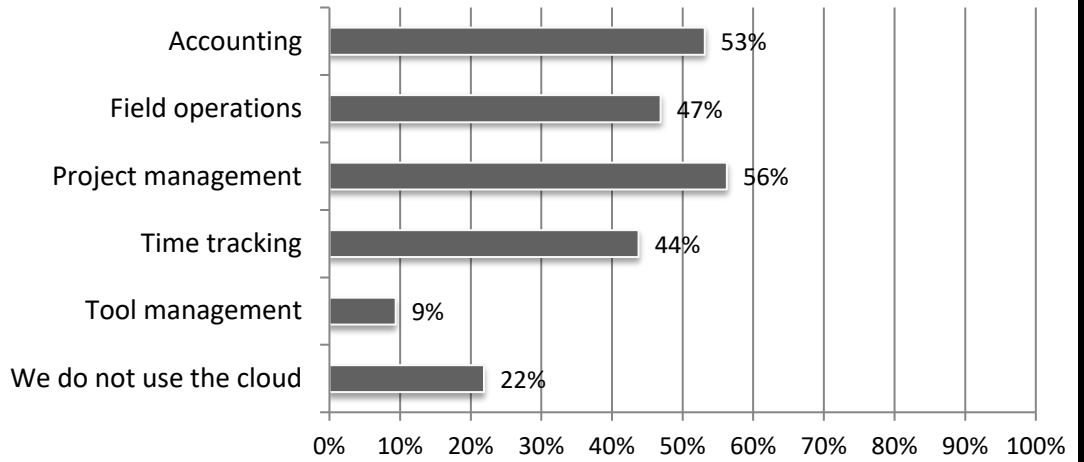


15. How does your company plan to use mobile software technology? (mark all that apply) Responses: 32

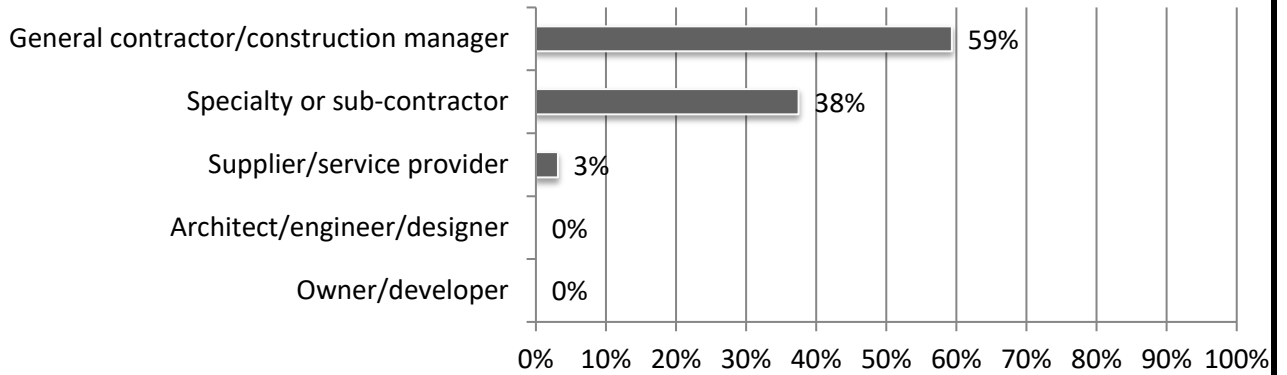


16. Does your firm use cloud-hosted technology in any of the following ways (mark all that apply)?

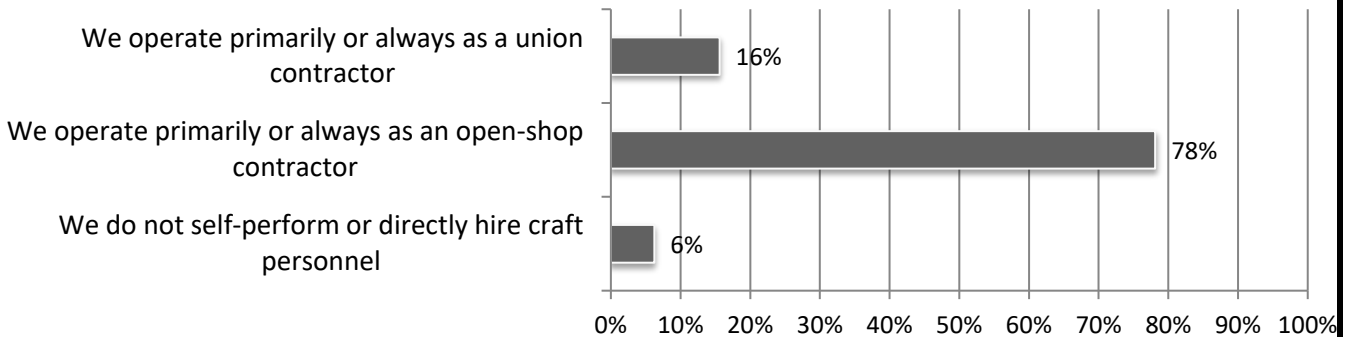

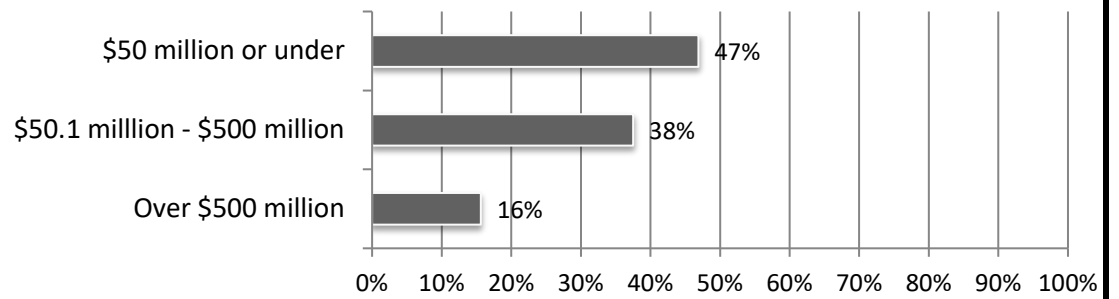


18. When you self-perform construction work, do you operate as a union contractor or an open-shop contractor?
