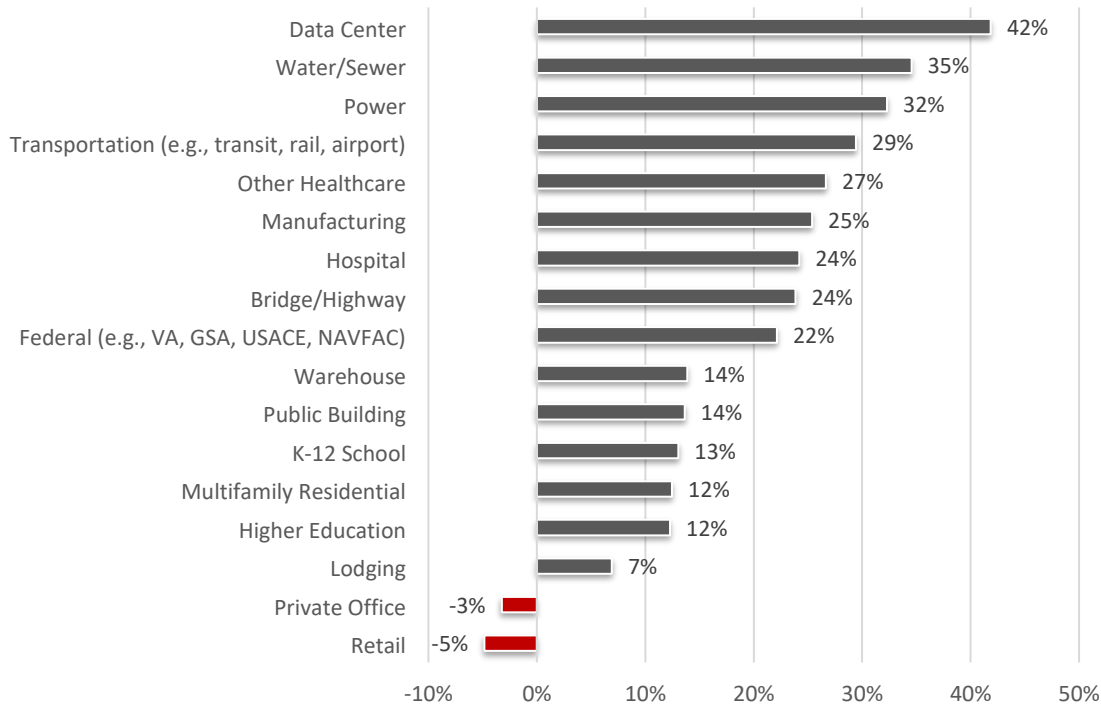

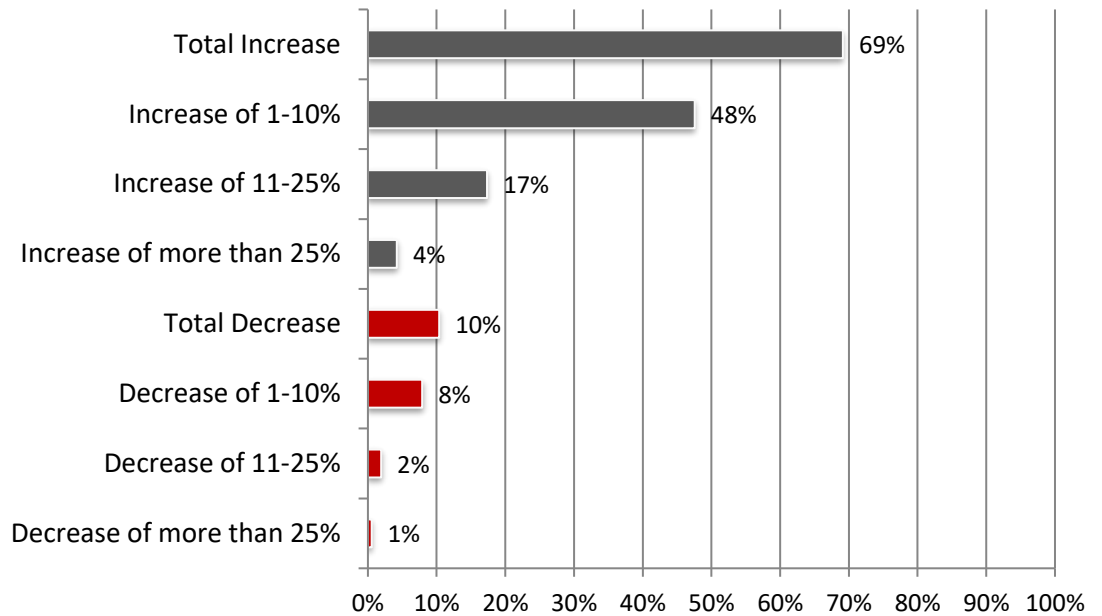
Net % expecting 2025 value of projects to be Higher or Lower than 2024



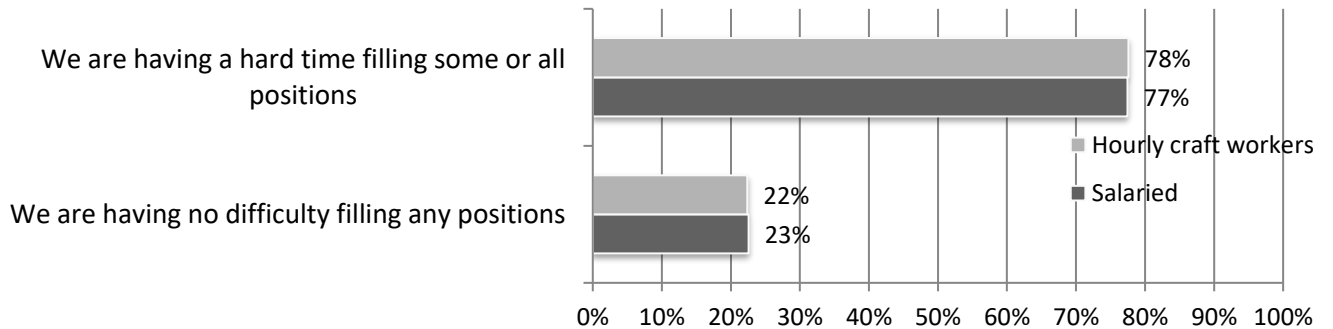

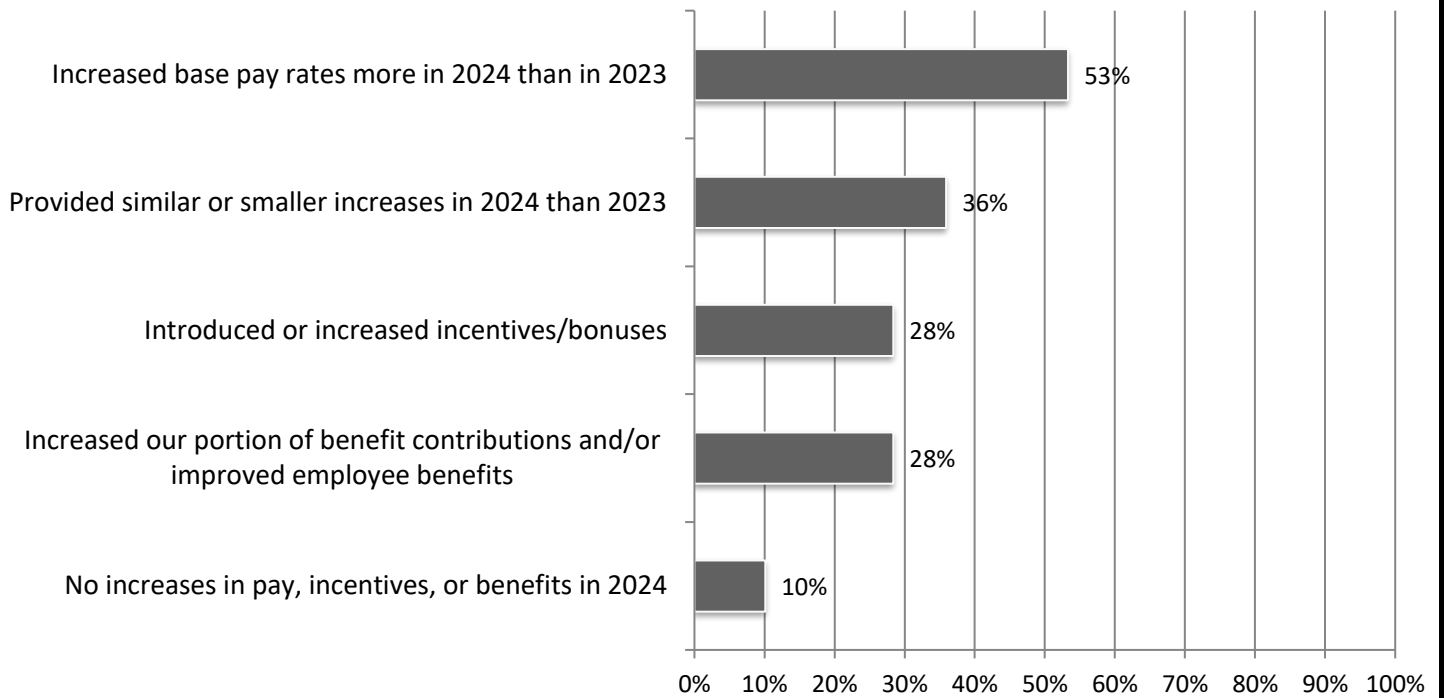

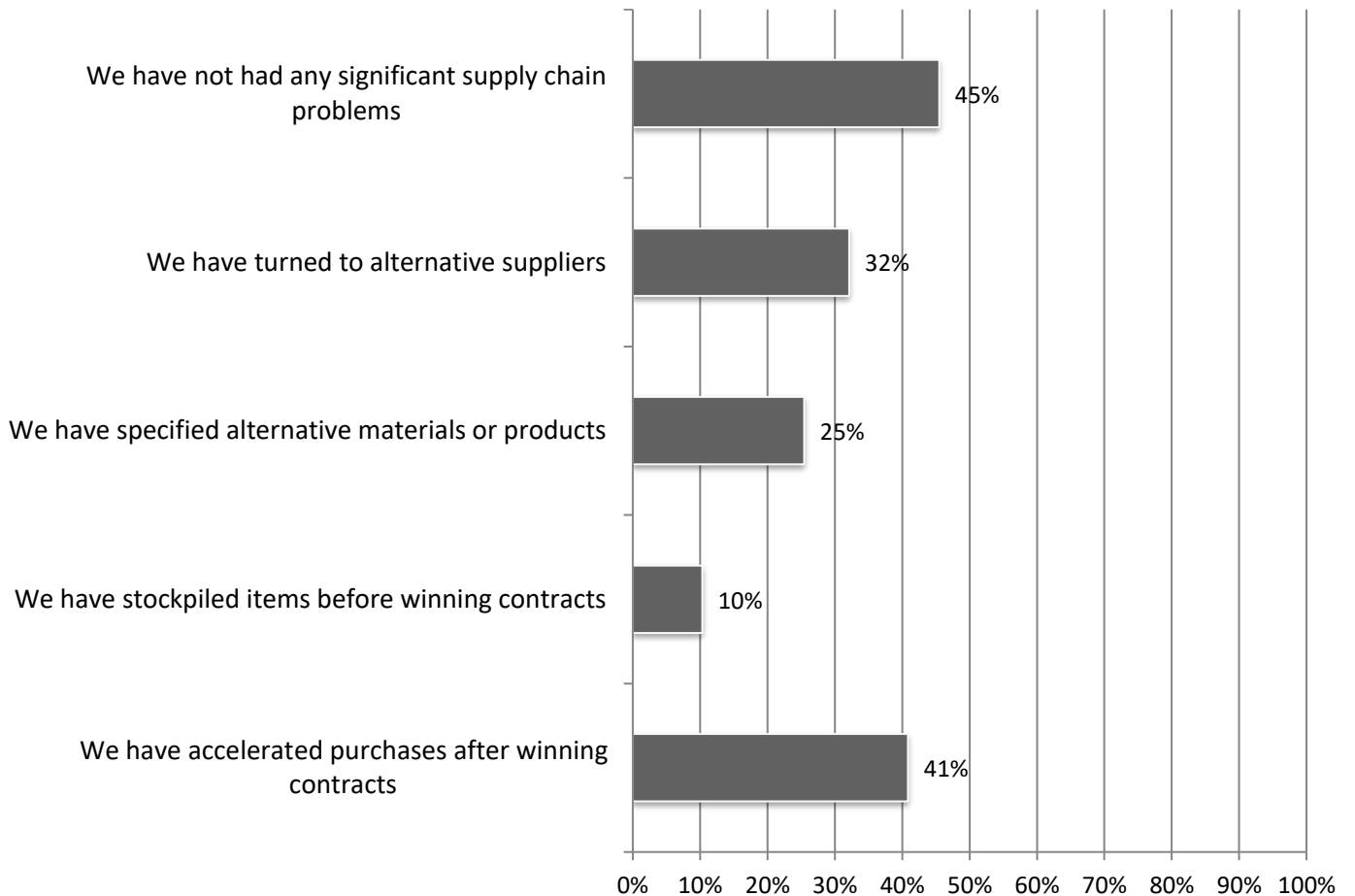

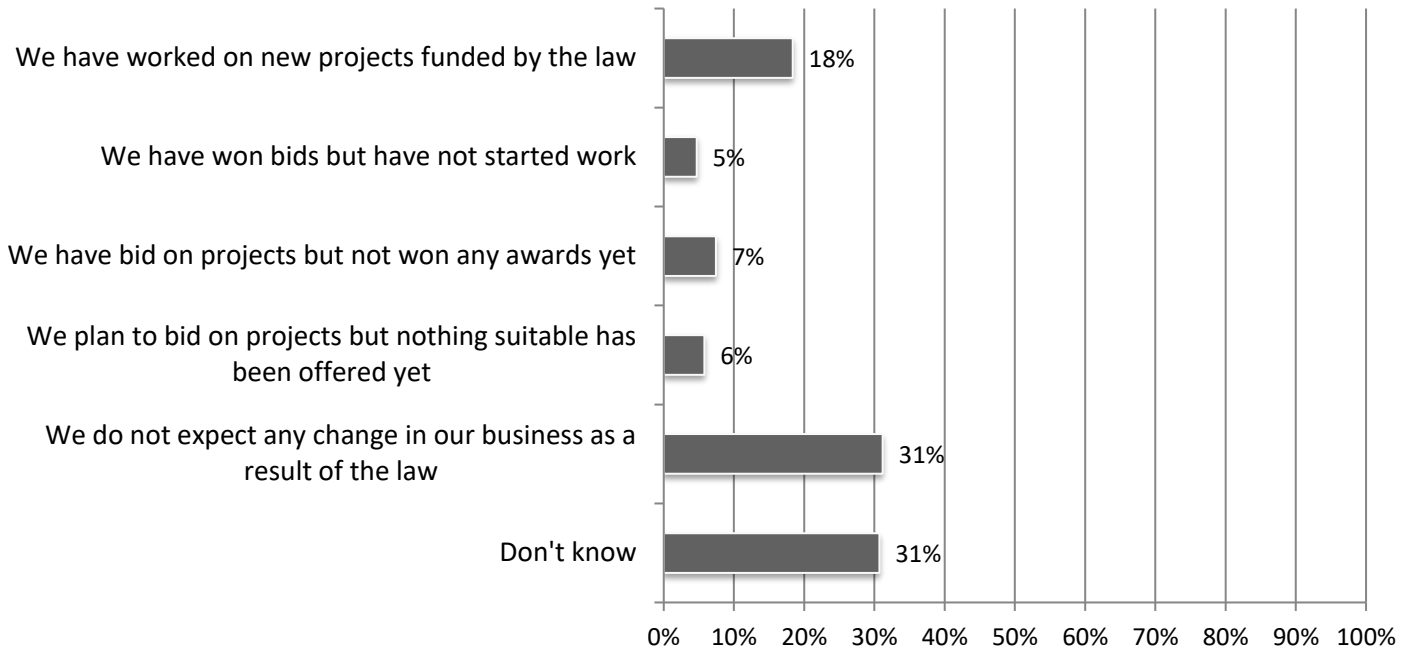
**5. What changes did your firm make in pay or benefits in 2024? (mark all that apply) Responses: 1,050**



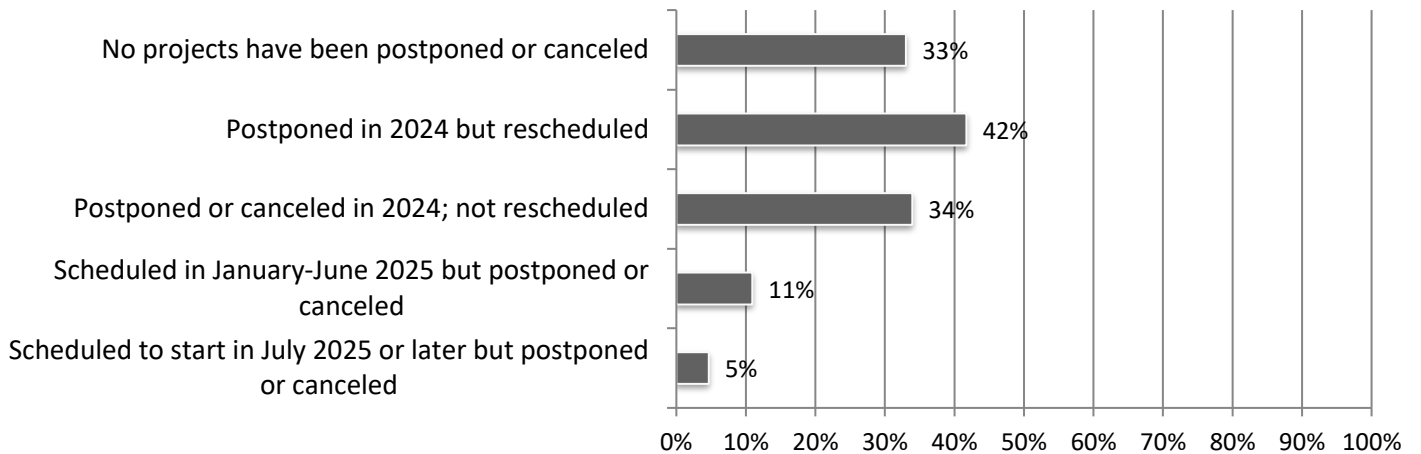
**6. How has your firm responded to supply-chain issues in 2024, if any? (mark all that apply) Responses: 1,018**



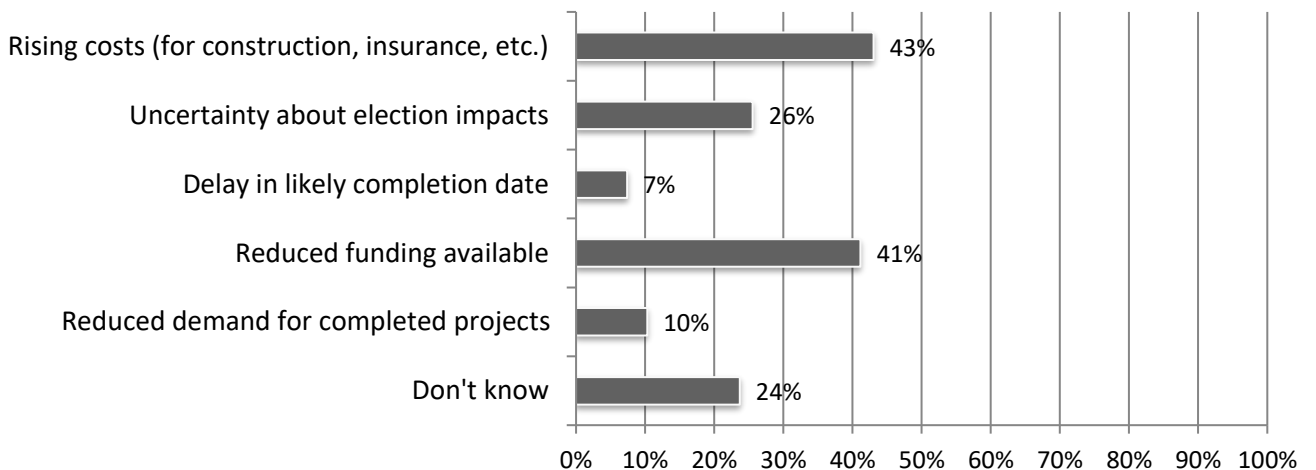

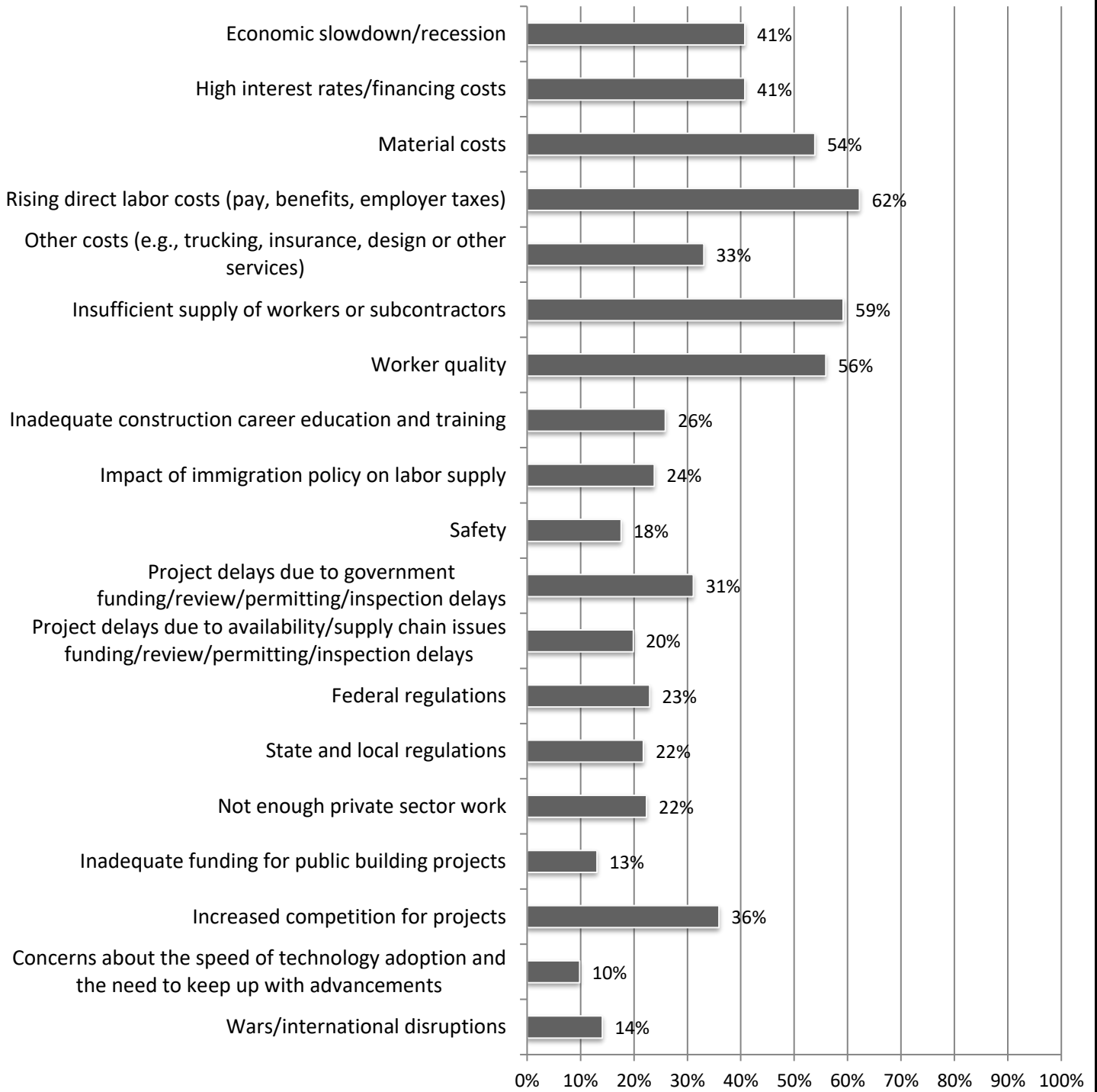
**8. Did an owner postpone or cancel any projects that were scheduled to start in 2024 or 2025? (mark all that apply) Responses: 1,026**



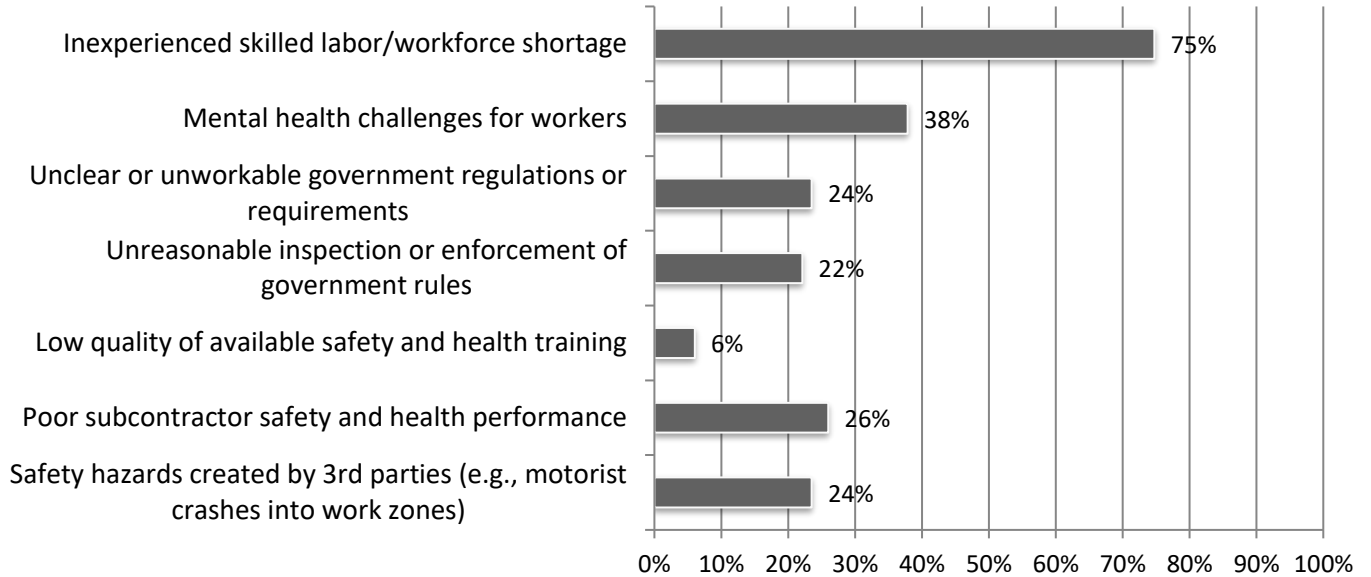

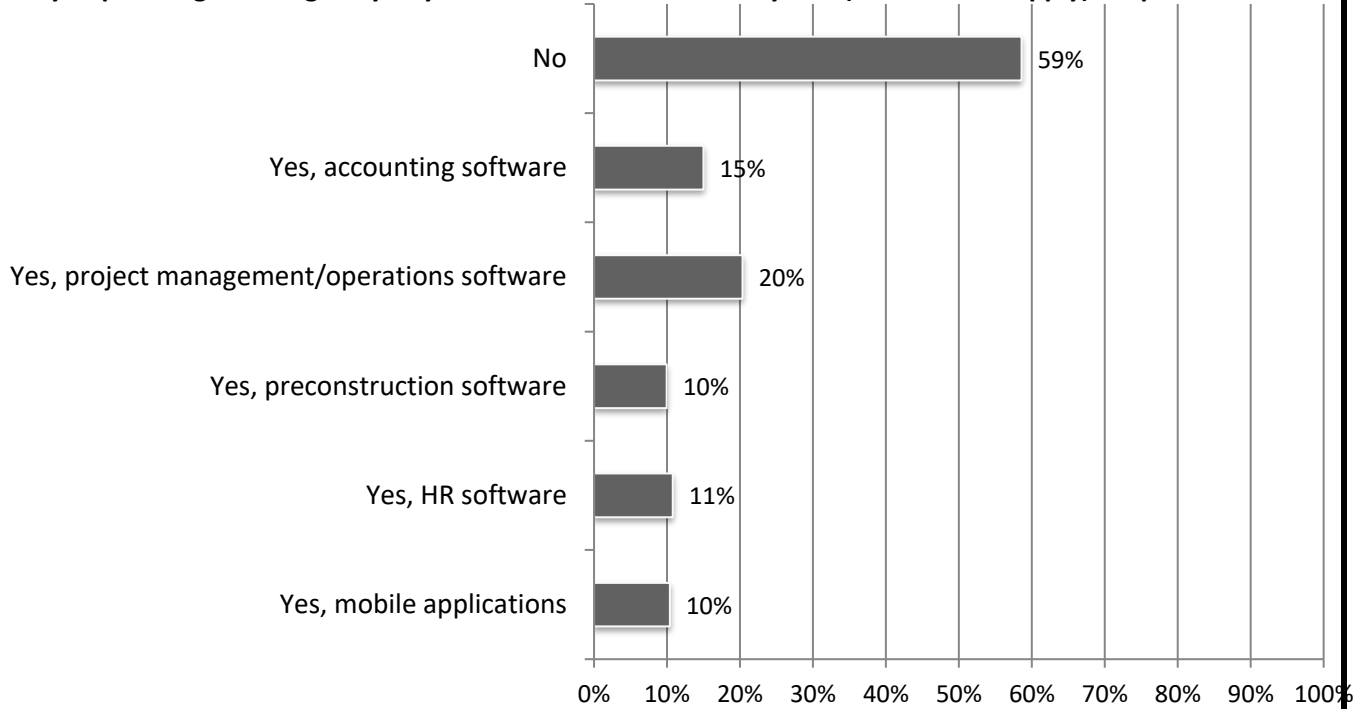

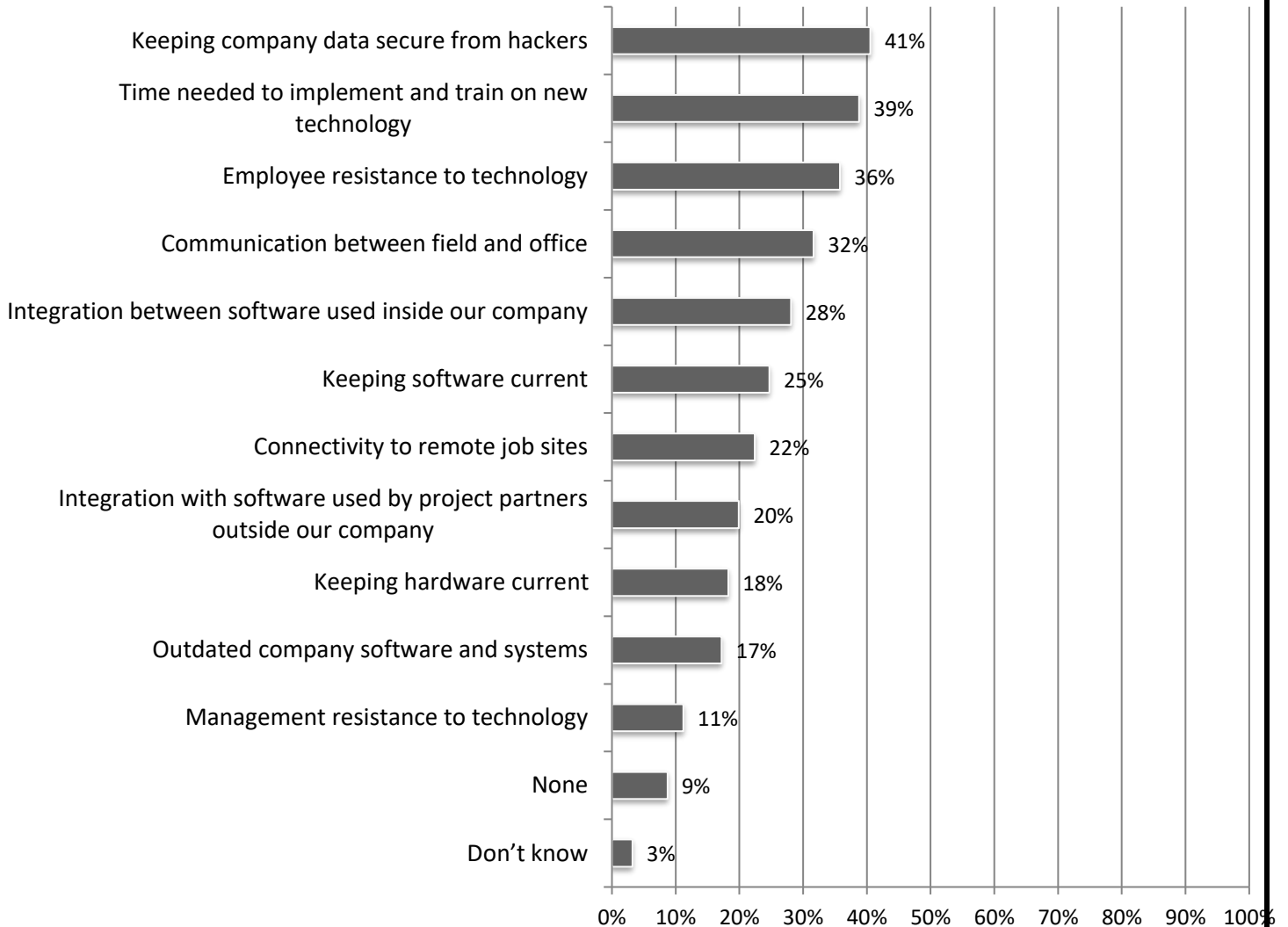

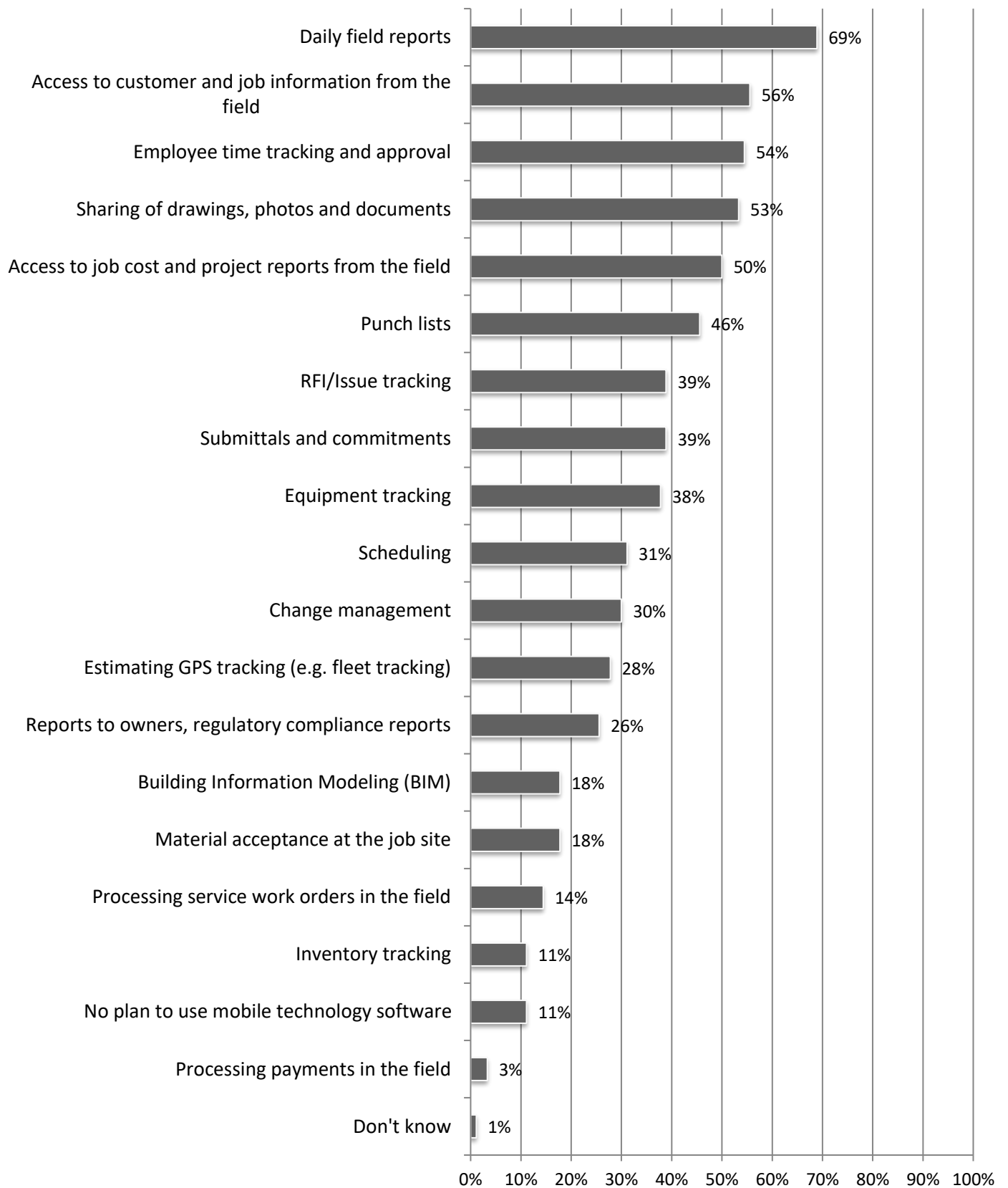

**14. What are your biggest IT challenges (mark all that apply)? Responses: 964**



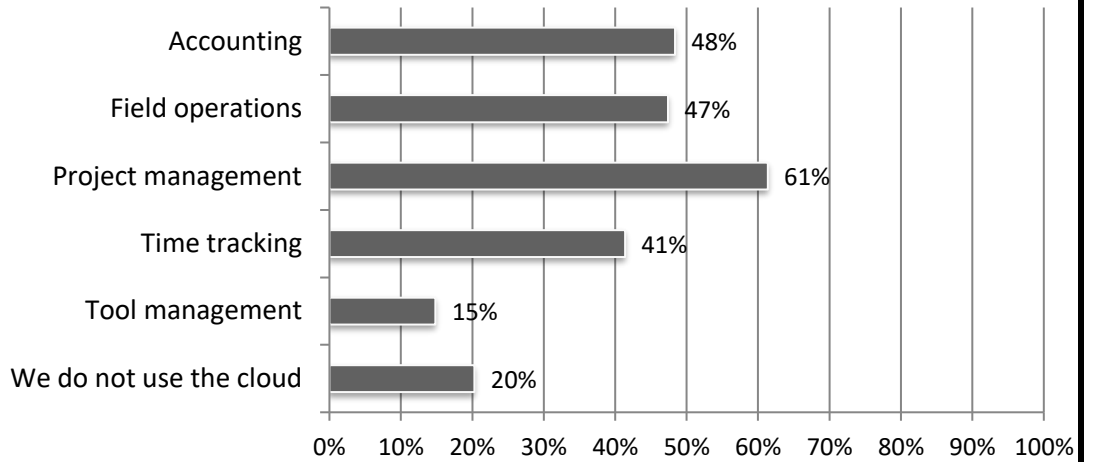
15. How does your company plan to use mobile software technology? (mark all that apply) Responses: 932



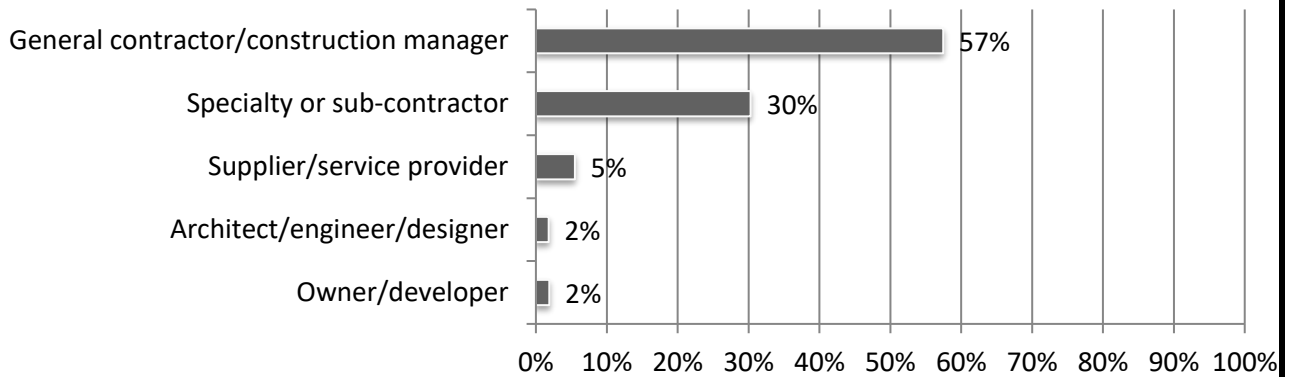


**16. Does your firm use cloud-hosted technology in any of the following ways (mark all that apply)?**

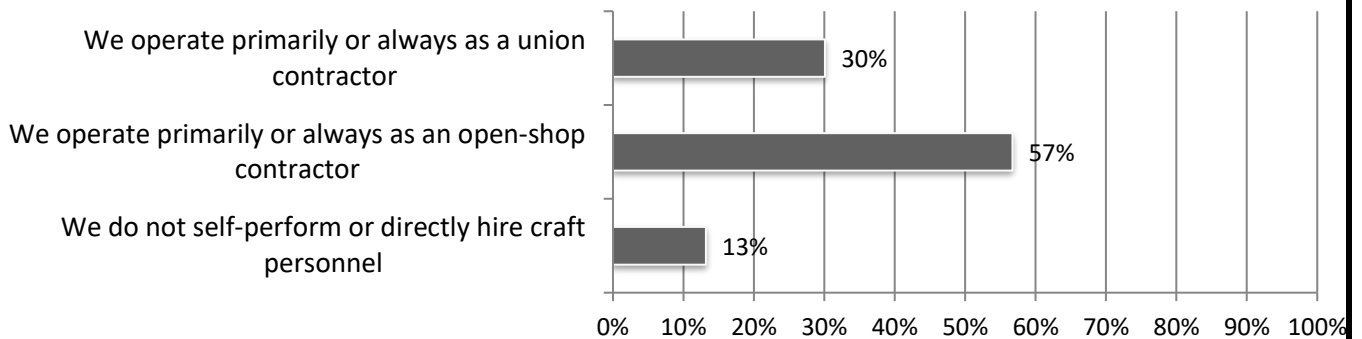


**17. What best describes your firm? Responses: 947**

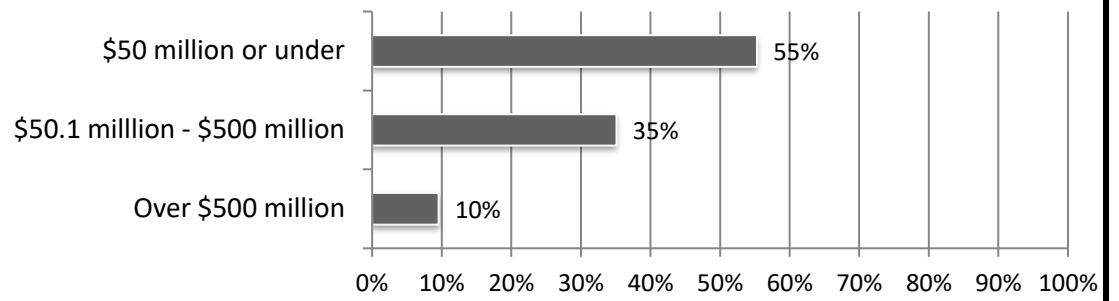


**18. When you self-perform construction work, do you operate as a union contractor or an open-shop contractor?**
