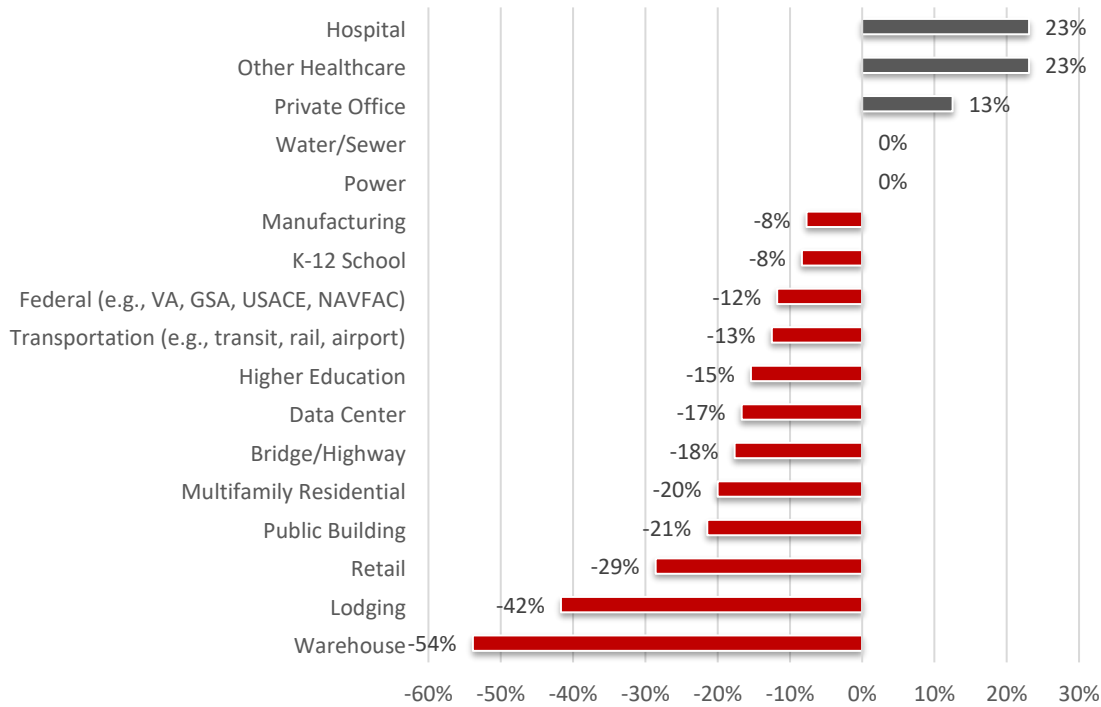

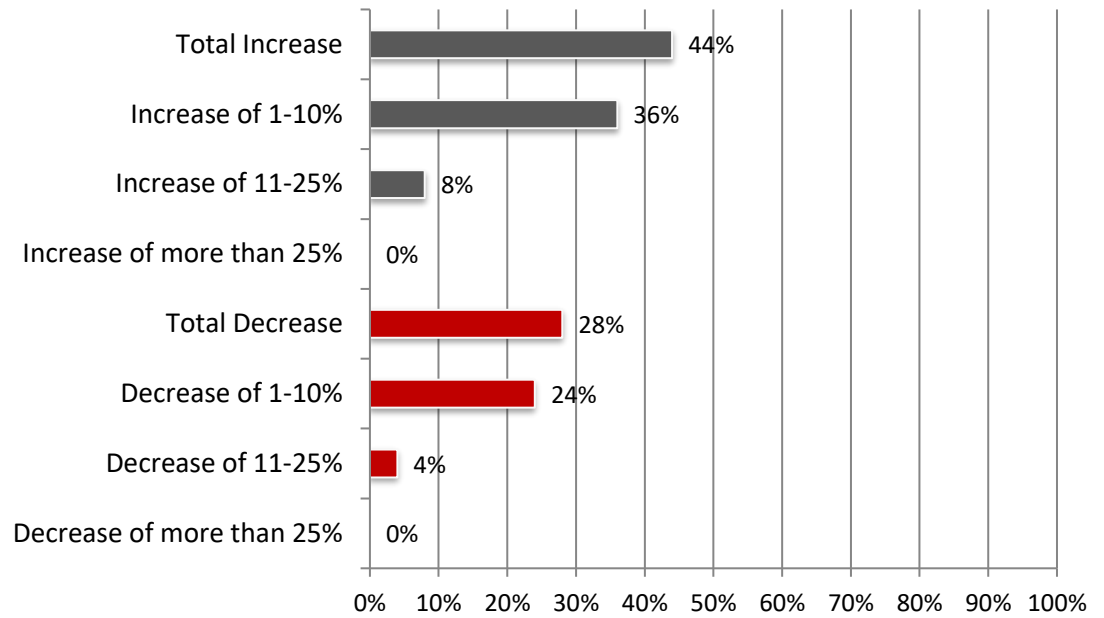

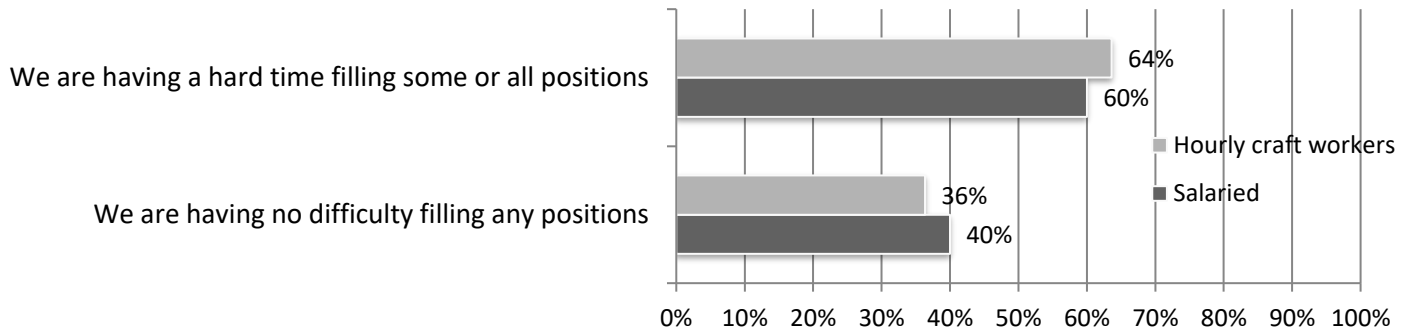

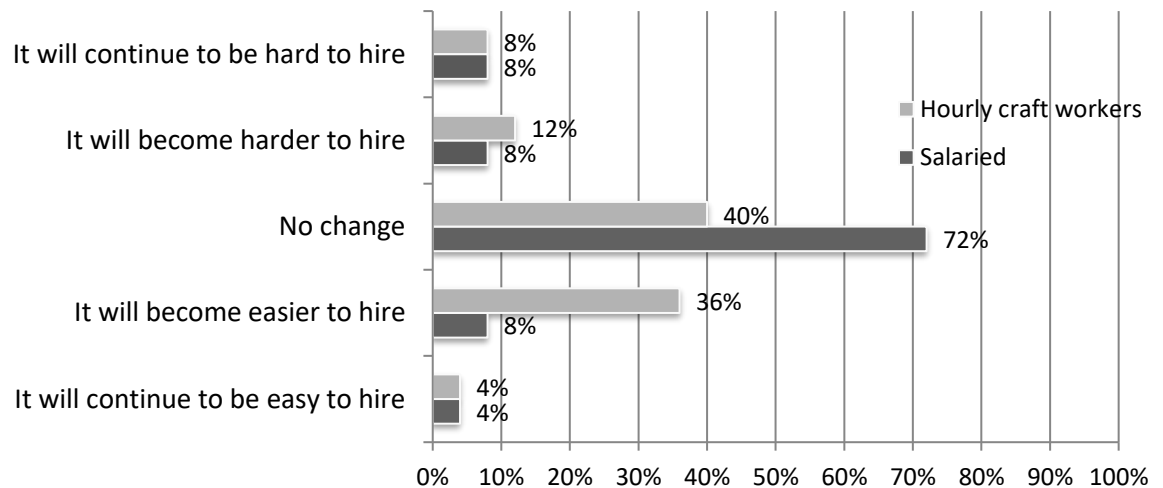

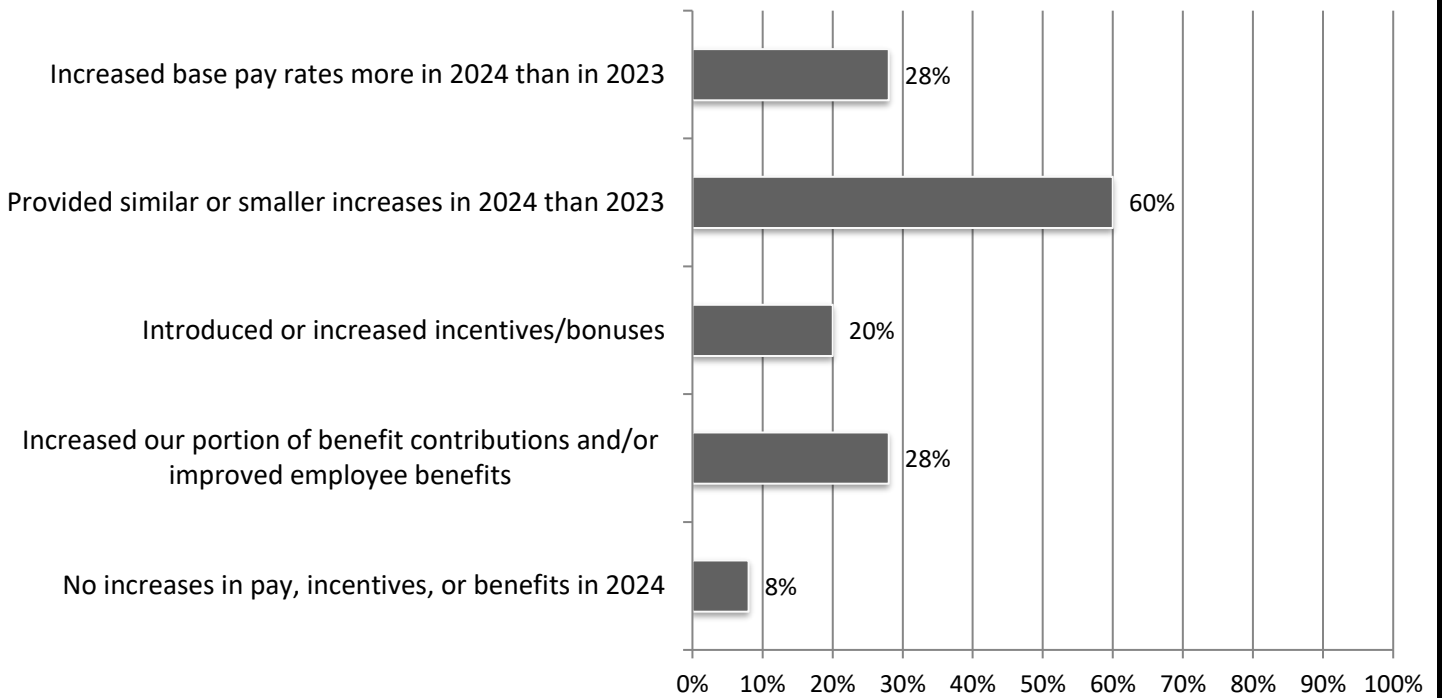

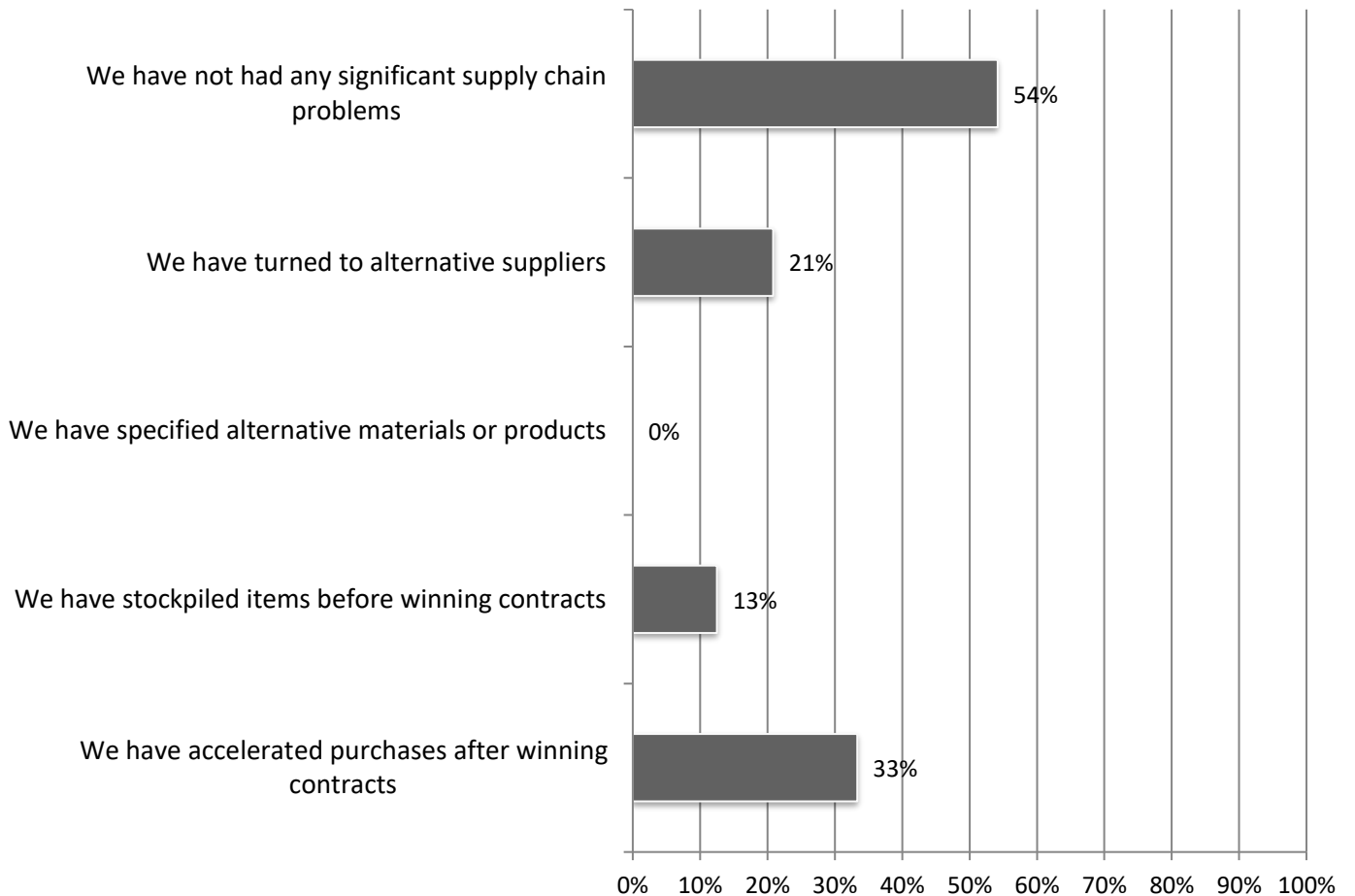
4. Do you expect any changes in the availability of hourly craft or salaried personnel over the coming 12 months? Responses: 25



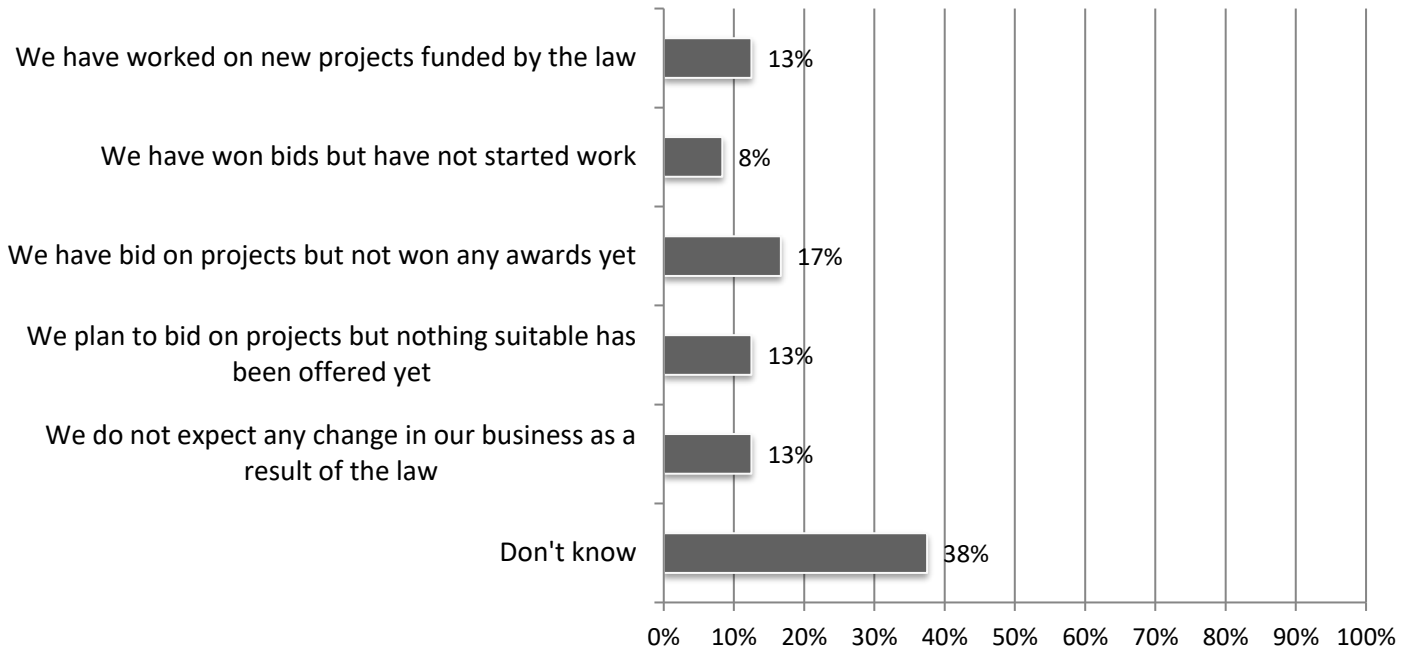
5. What changes did your firm make in pay or benefits in 2024? (mark all that apply) Responses: 25



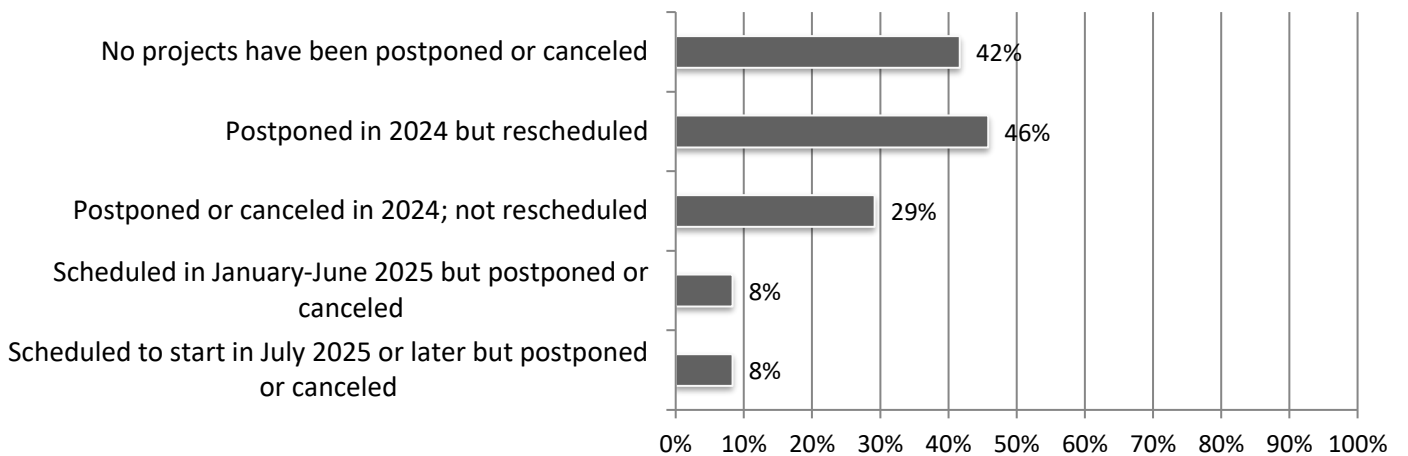
6. How has your firm responded to supply-chain issues in 2024, if any? (mark all that apply) Responses: 24



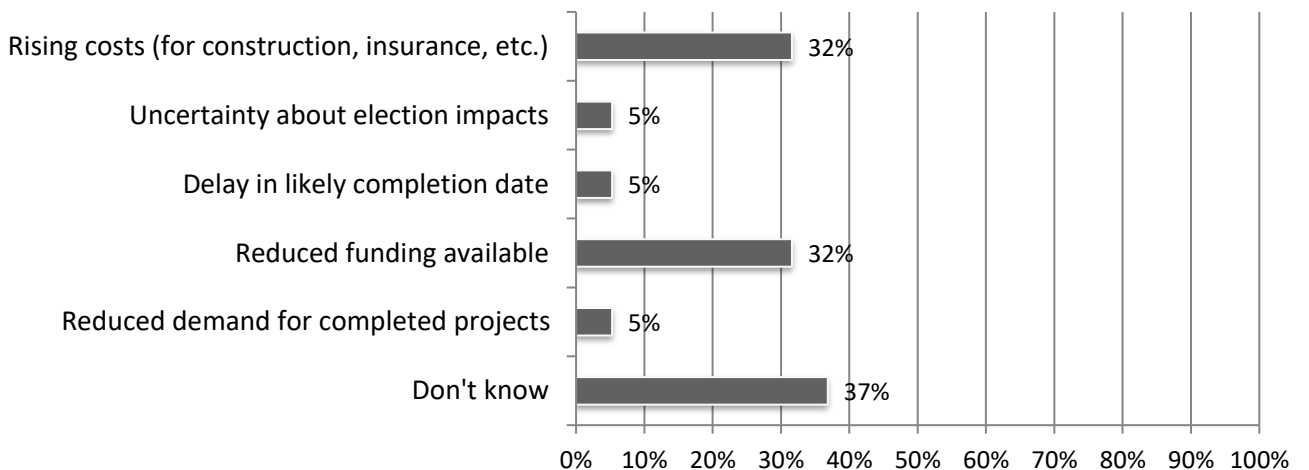
7. What difference, if any, has the Infrastructure Investment and Jobs Act (also known as the Bipartisan Infrastructure Law), made to your business? Responses: 24



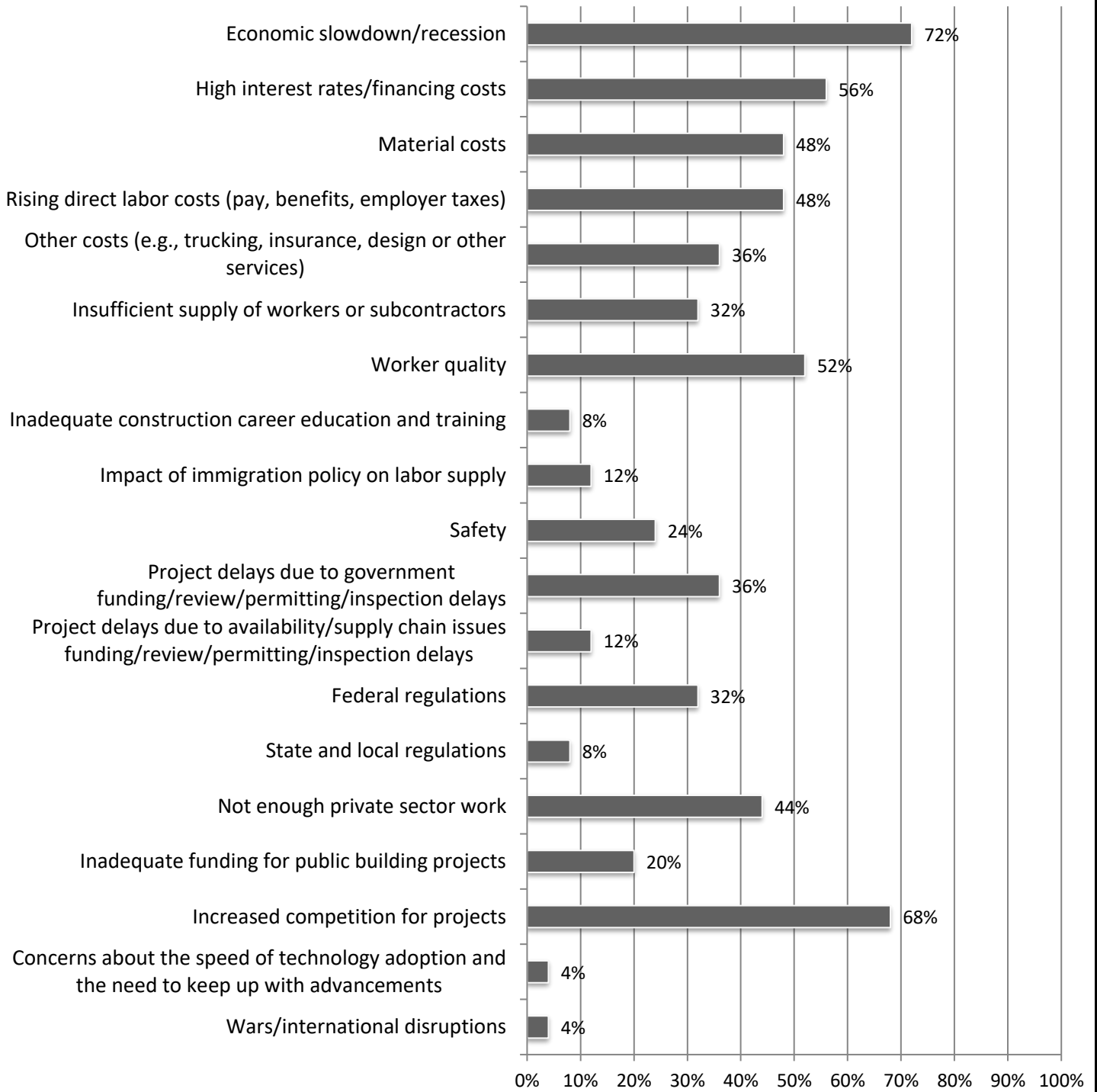

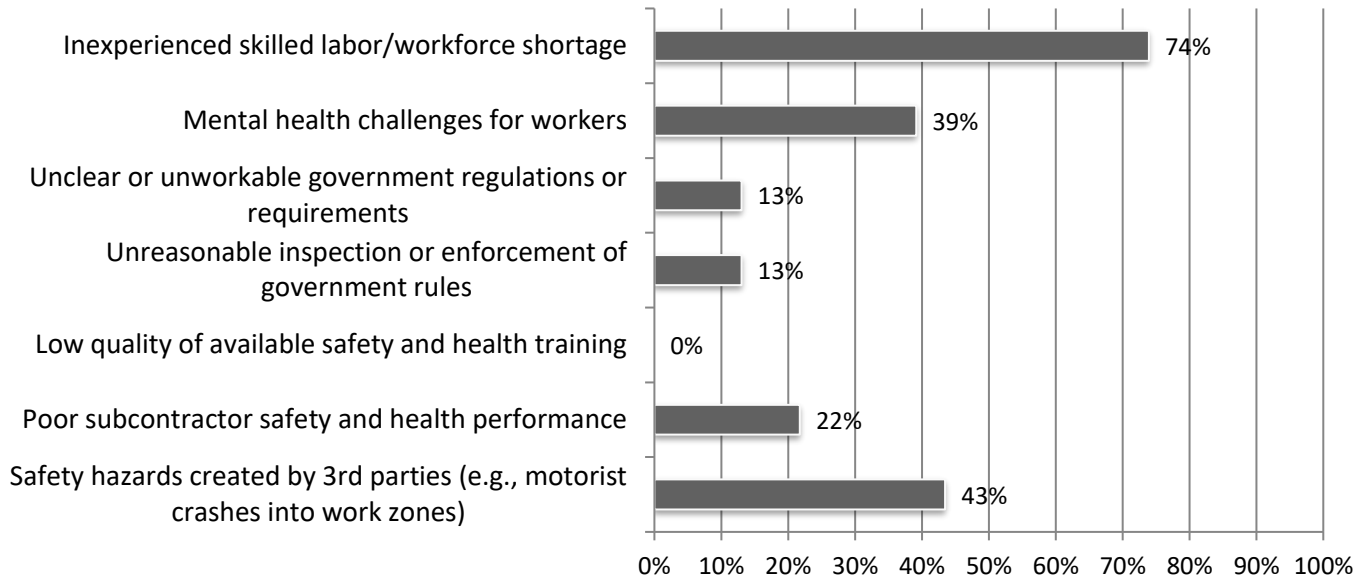

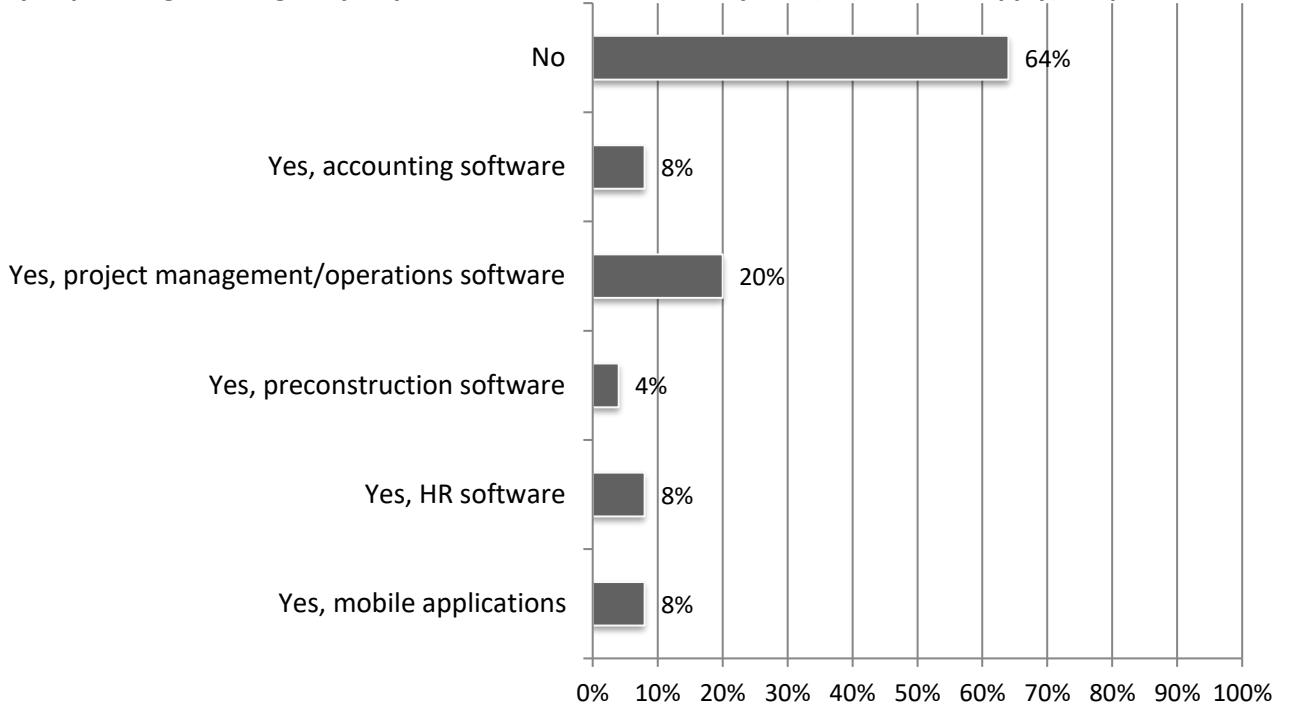

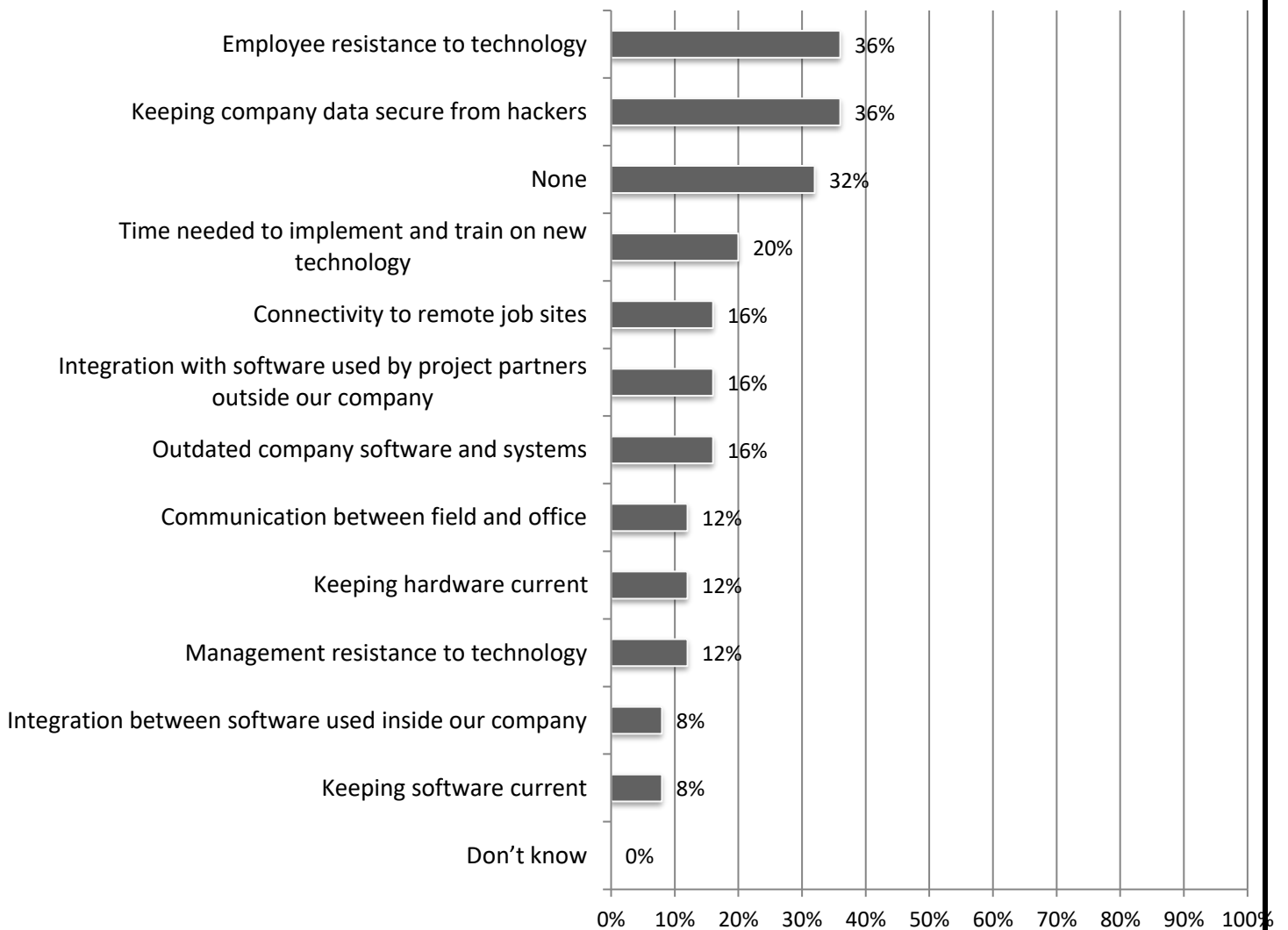

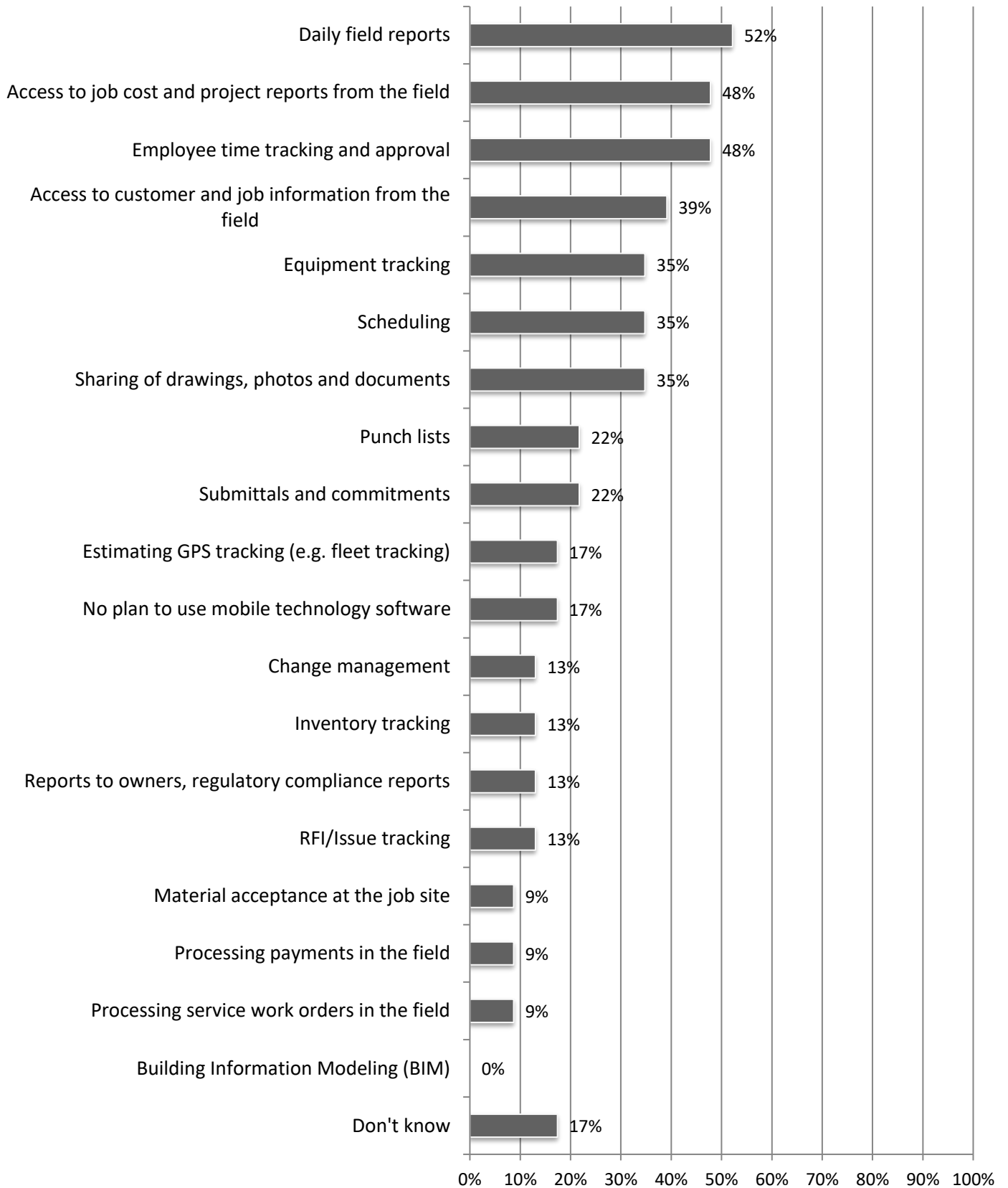

14. What are your biggest IT challenges (mark all that apply)? Responses: 25

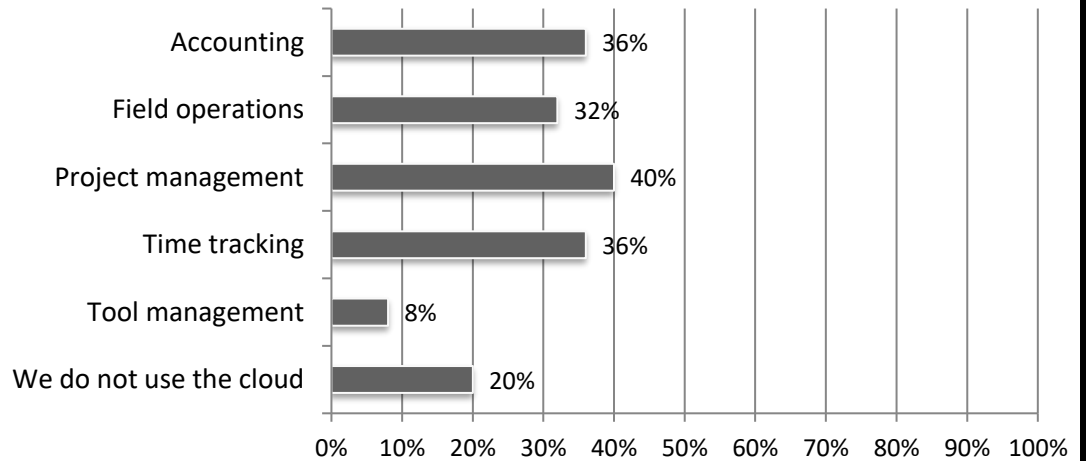


15. How does your company plan to use mobile software technology? (mark all that apply) Responses: 23

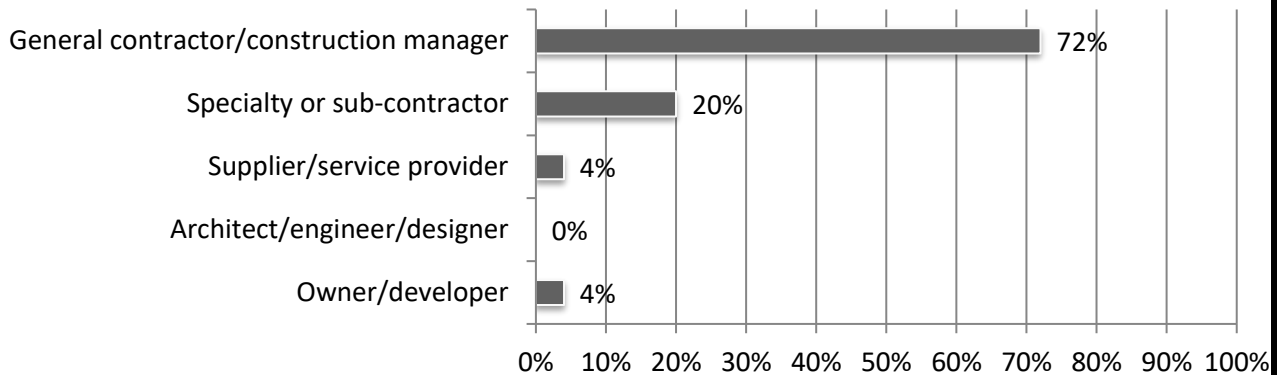


16. Does your firm use cloud-hosted technology in any of the following ways (mark all that apply)?

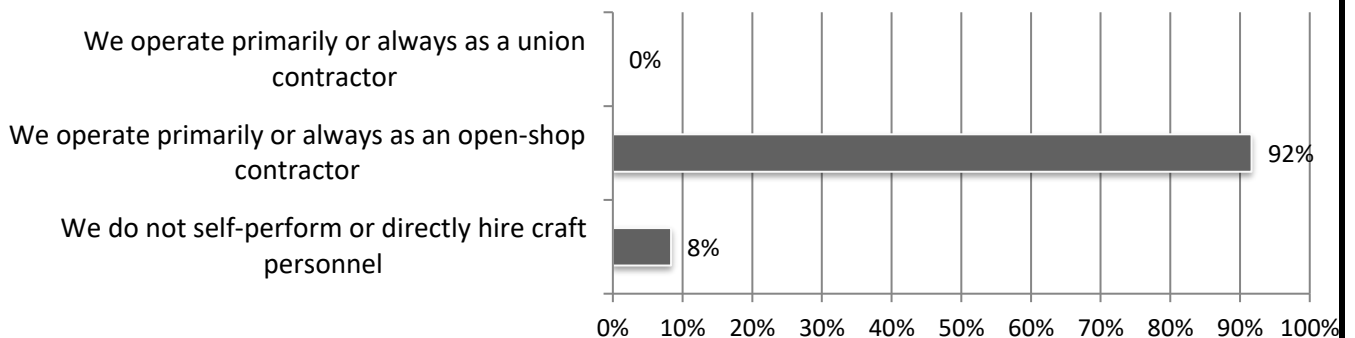


17. What best describes your firm? Responses: 25

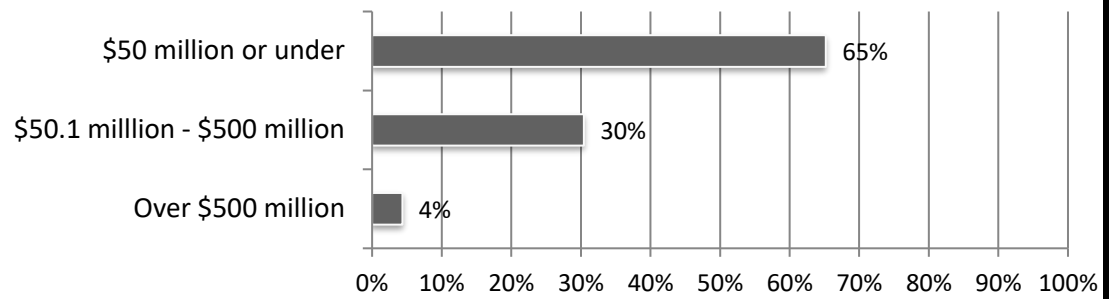


18. When you self-perform construction work, do you operate as a union contractor or an open-shop contractor?
