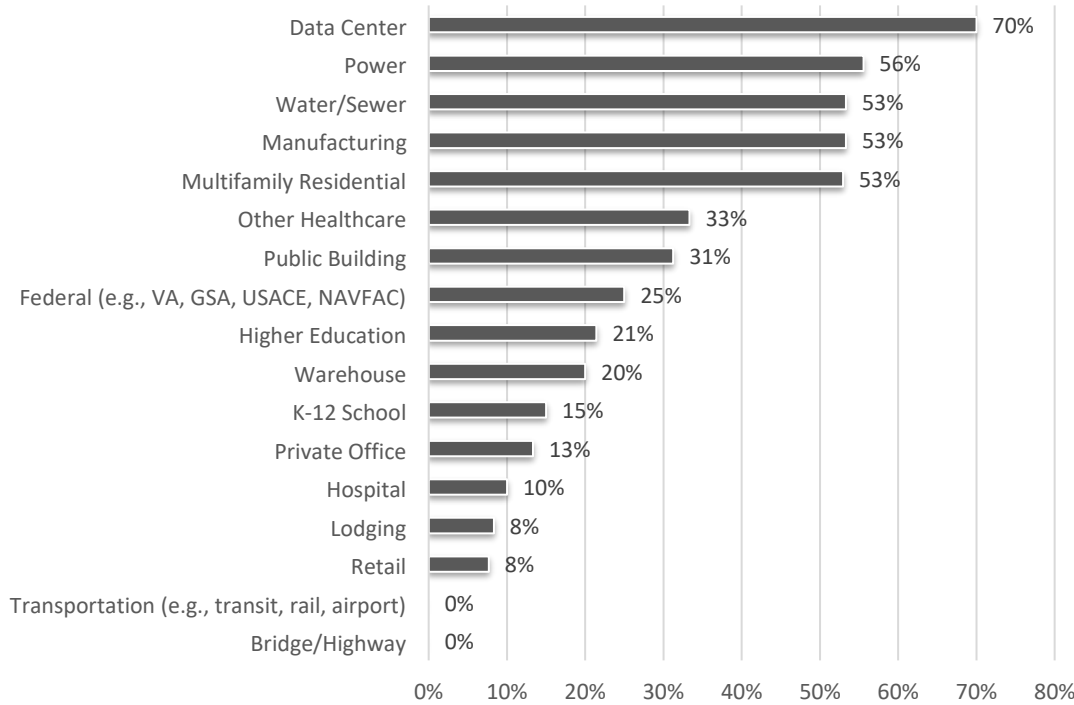

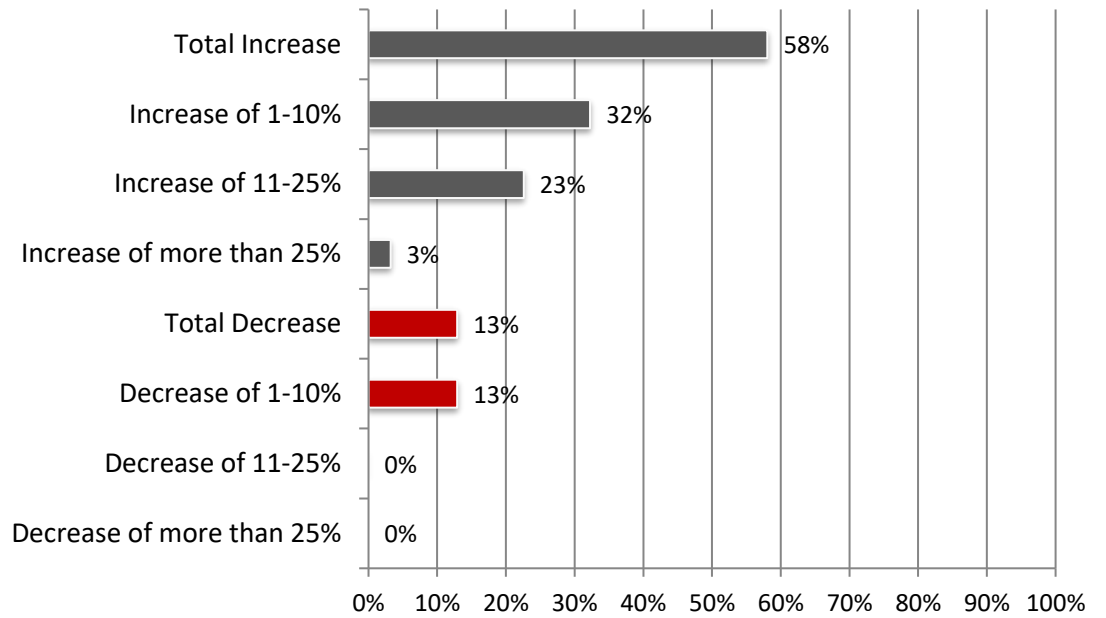
Net % expecting 2025 value of projects to be Higher or Lower than 2024



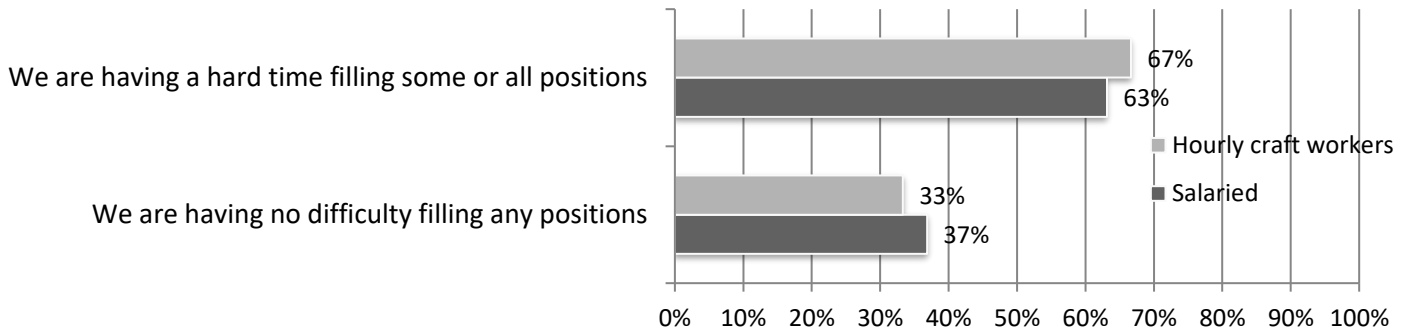

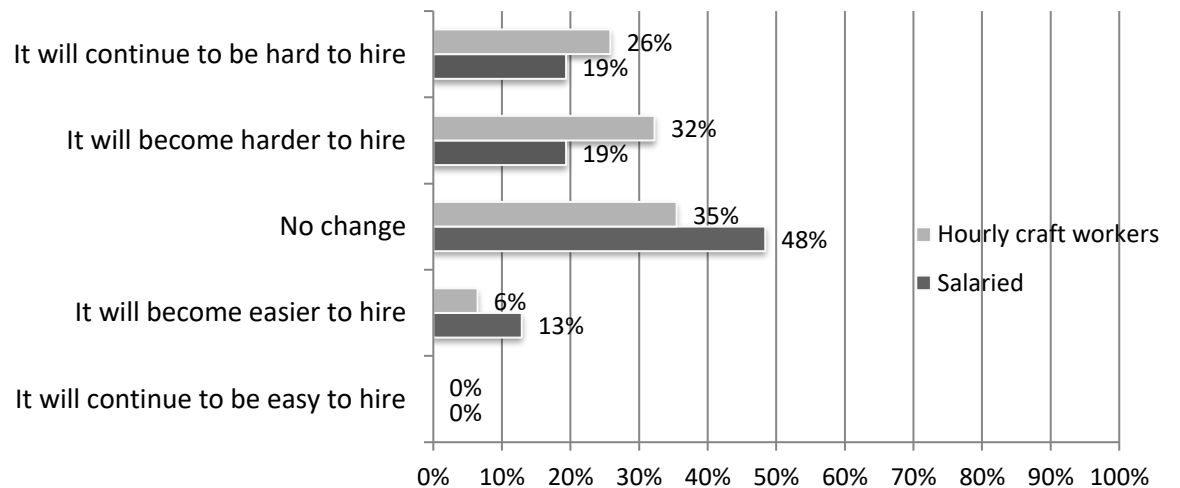

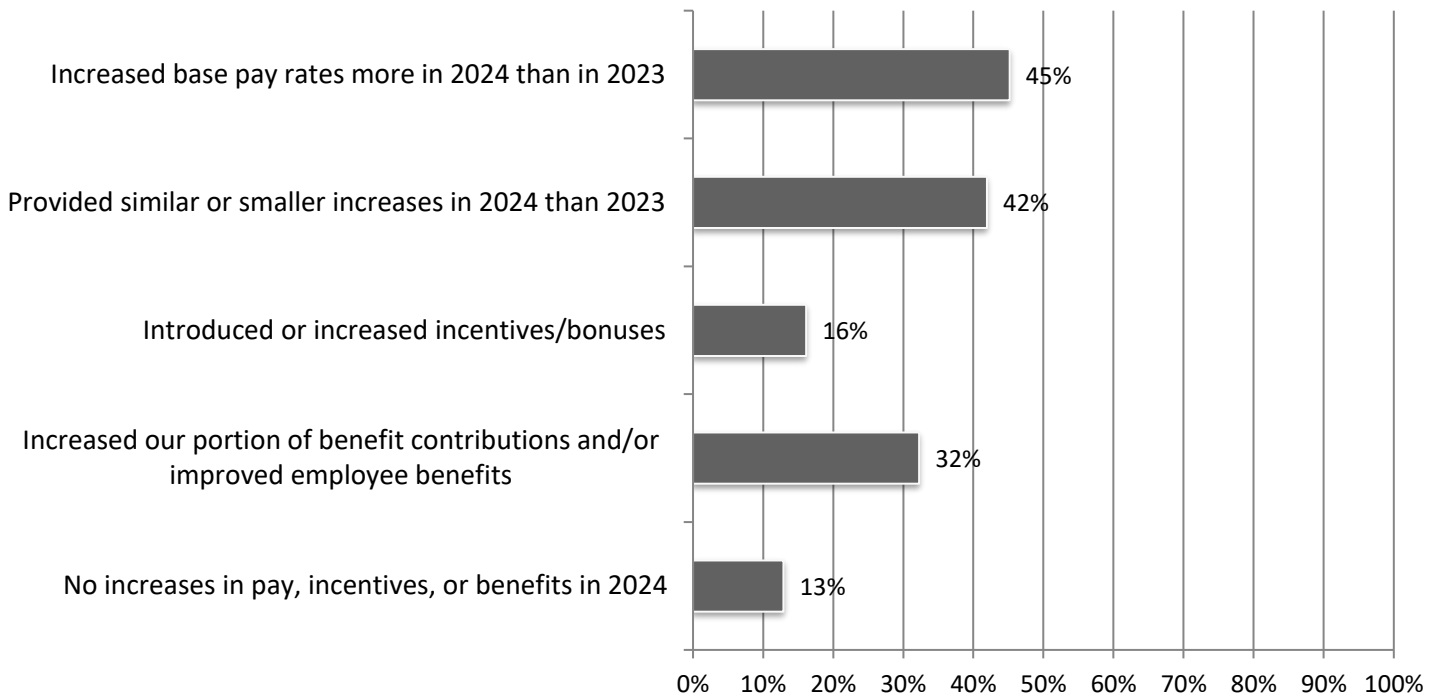

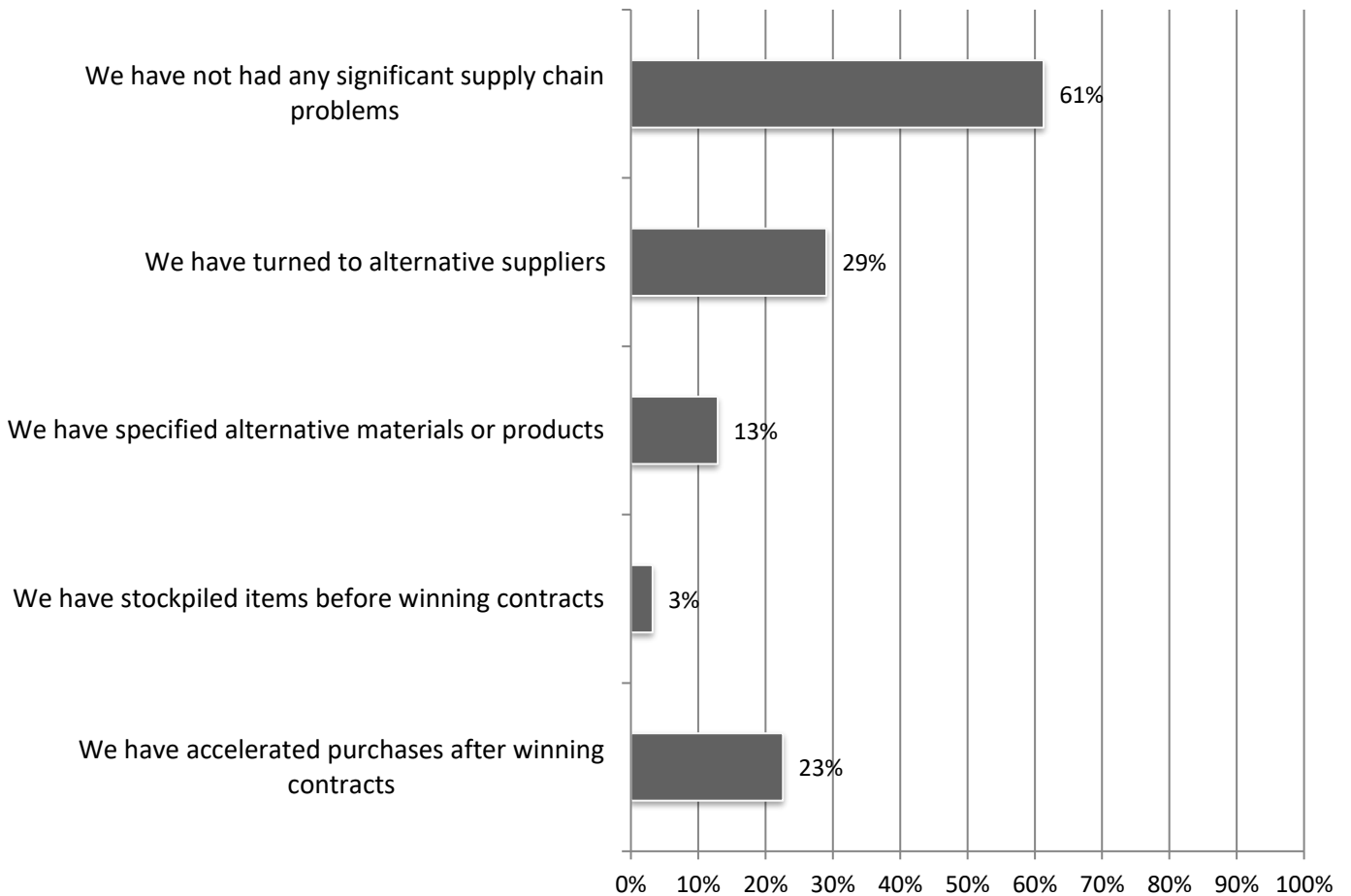
**4. Do you expect any changes in the availability of hourly craft or salaried personnel over the coming 12 months? Responses: 31**



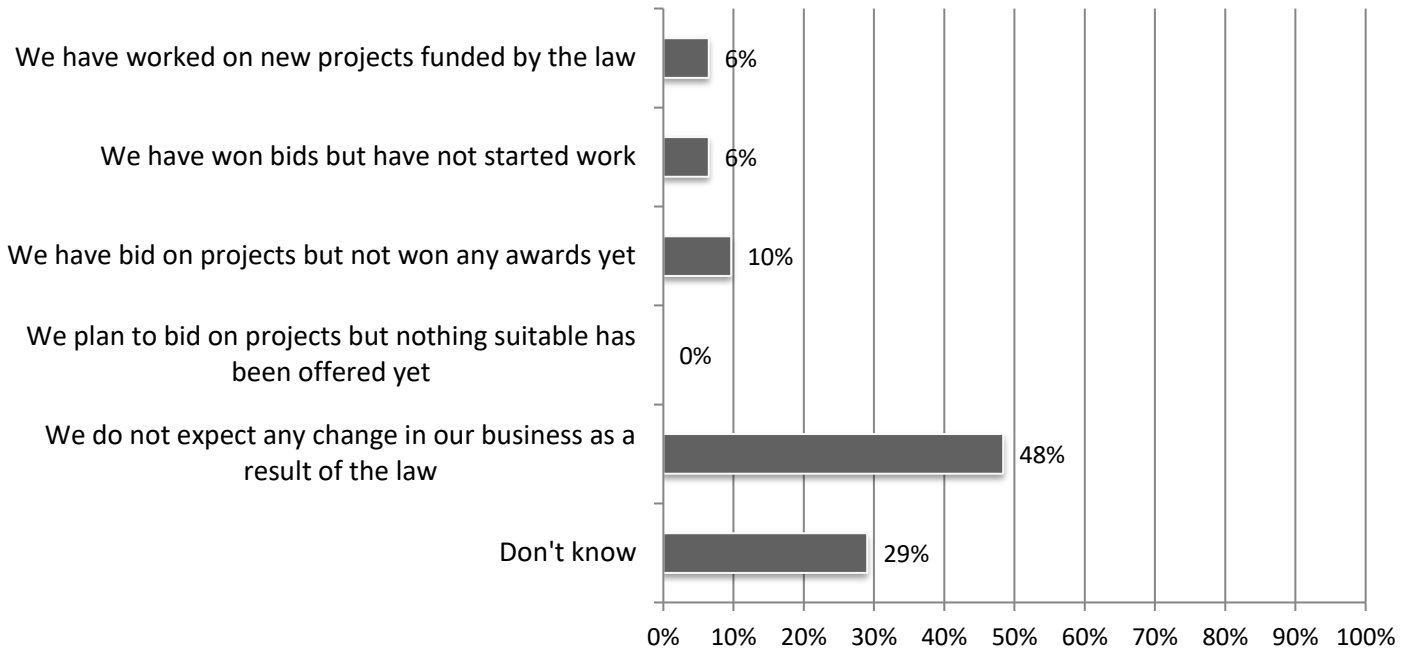
**5. What changes did your firm make in pay or benefits in 2024? (mark all that apply) Responses: 31**



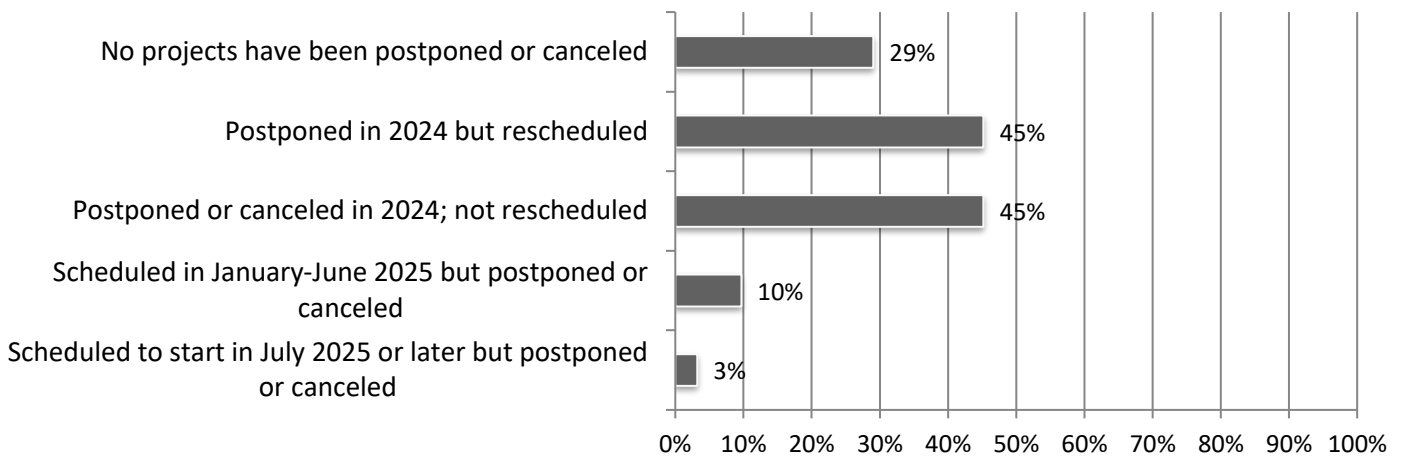

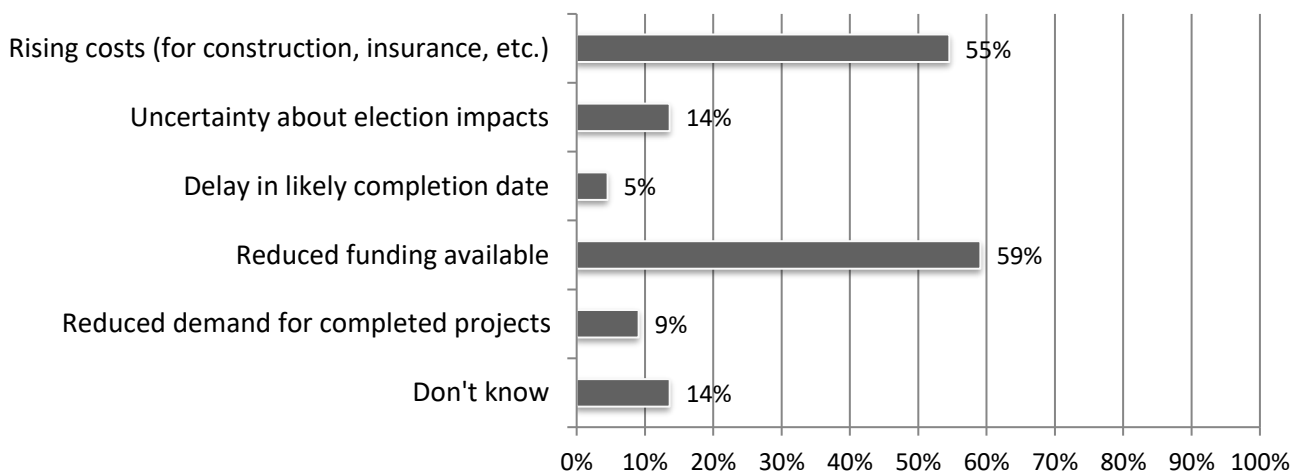

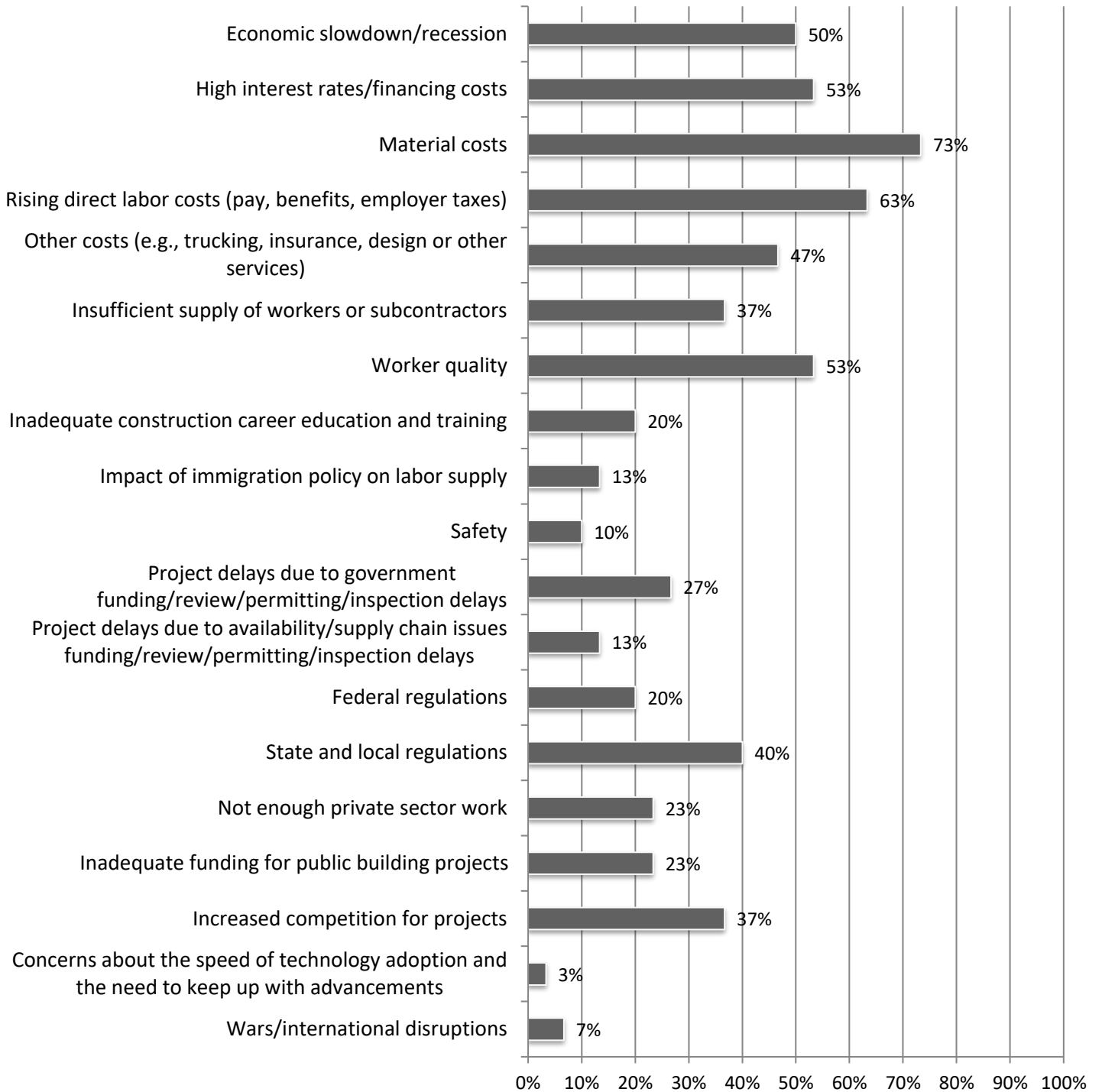
**8. Did an owner postpone or cancel any projects that were scheduled to start in 2024 or 2025? (mark all that apply) Responses: 31**



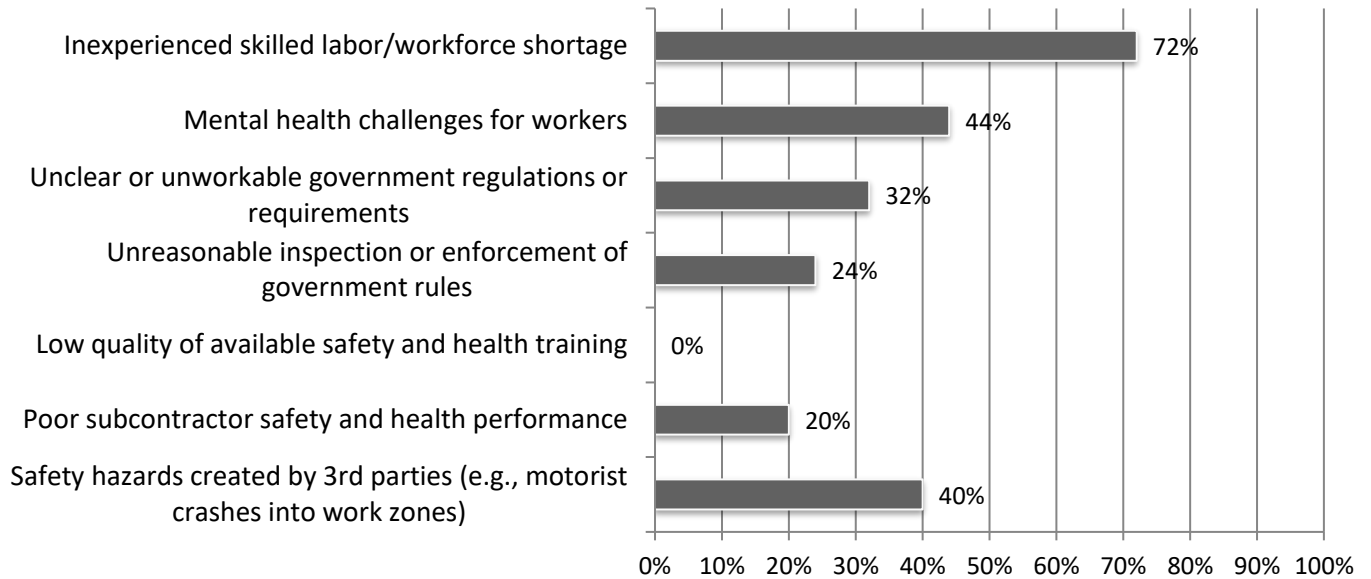

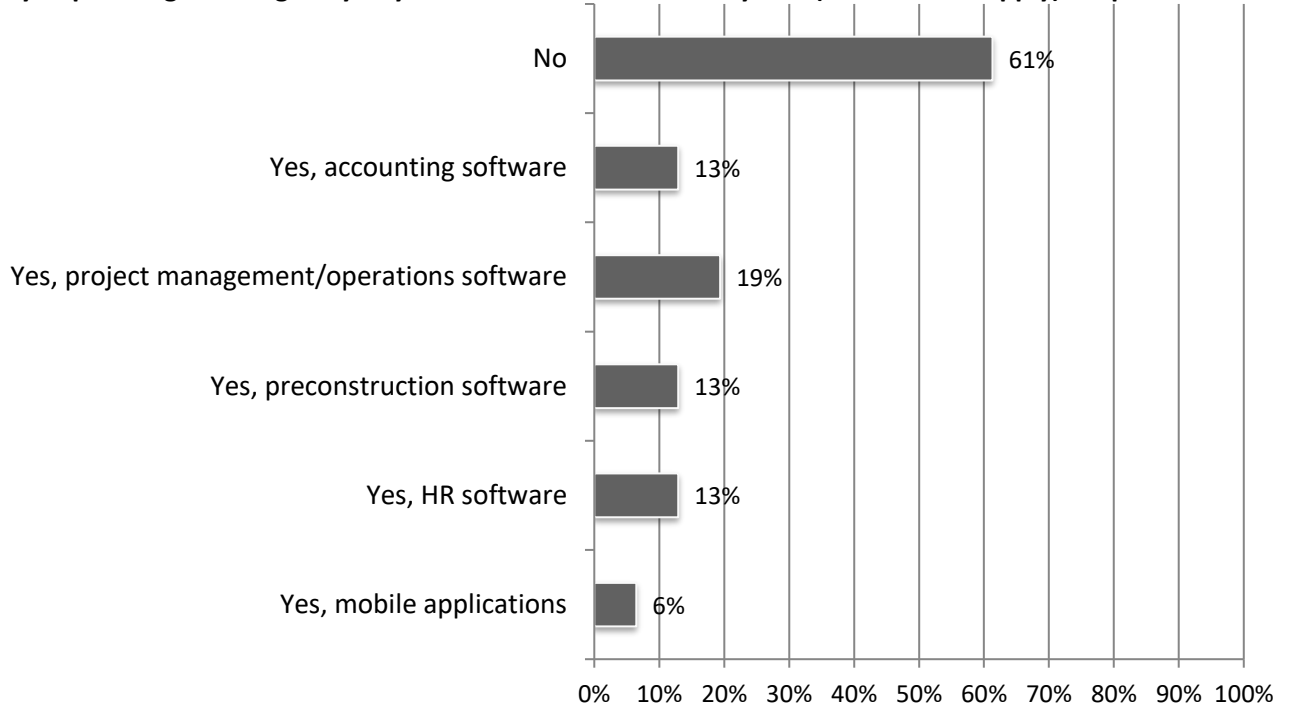

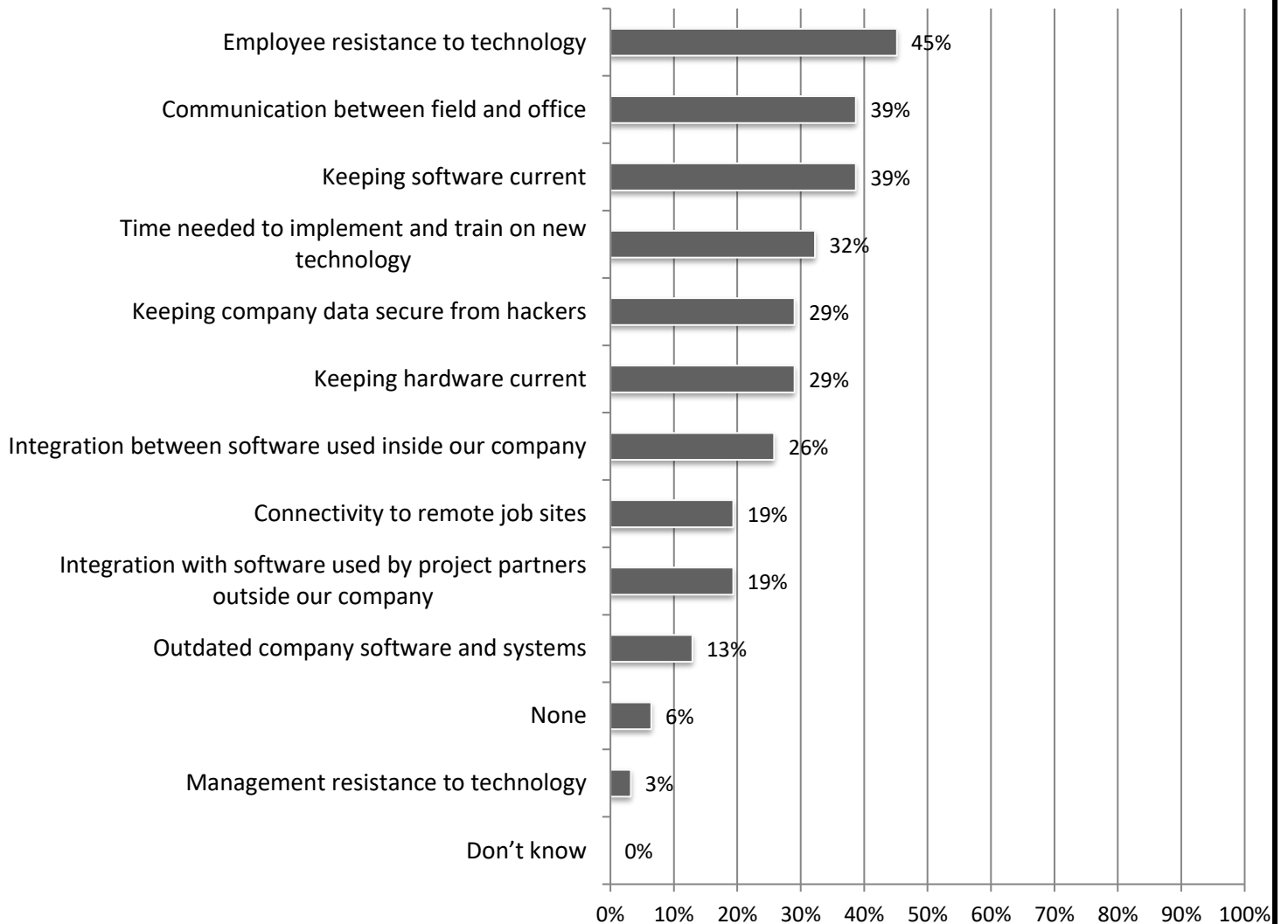

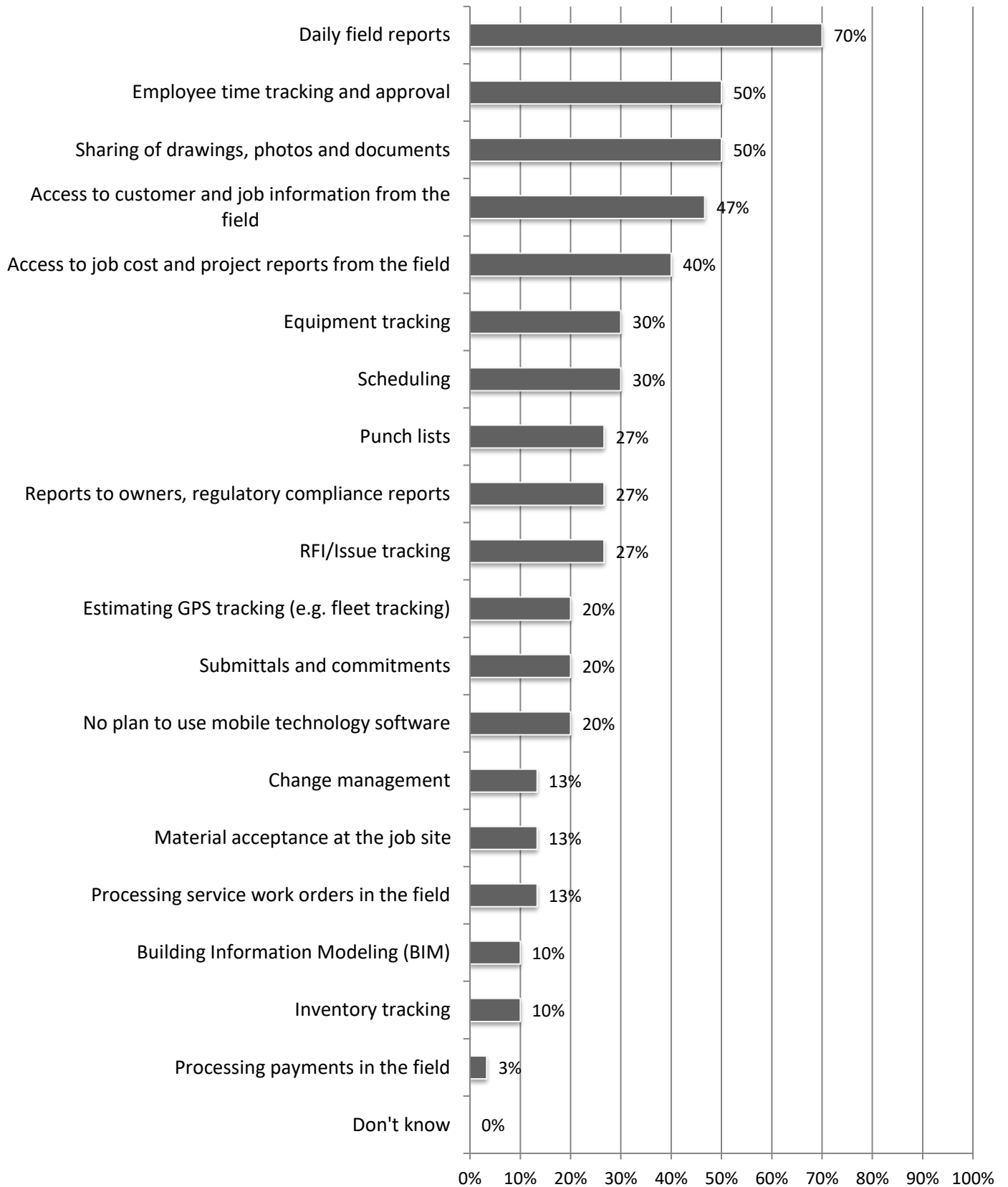

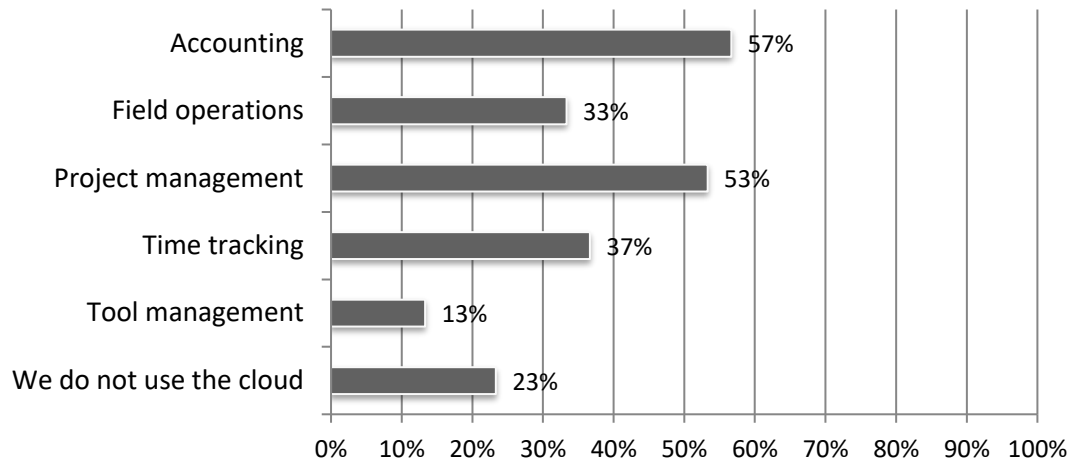
15. How does your company plan to use mobile software technology? (mark all that apply) Responses: 30



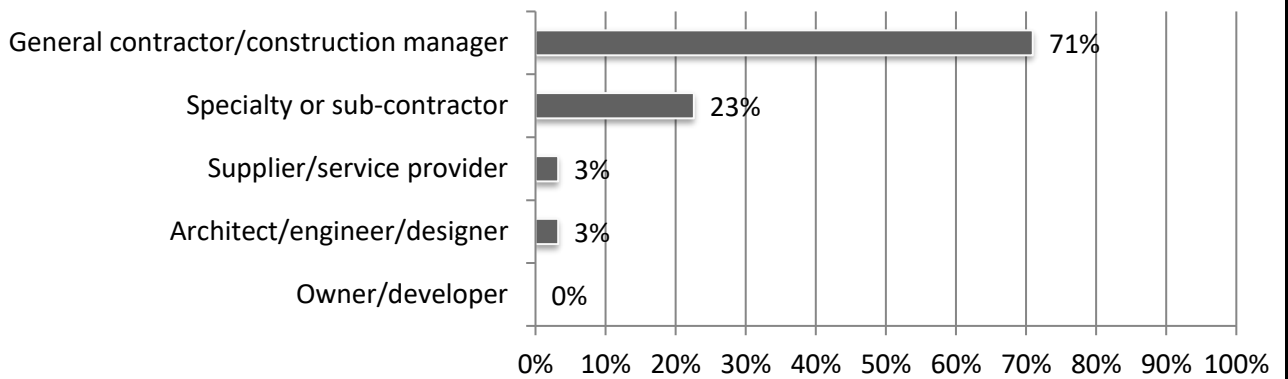


**16. Does your firm use cloud-hosted technology in any of the following ways (mark all that apply)?**

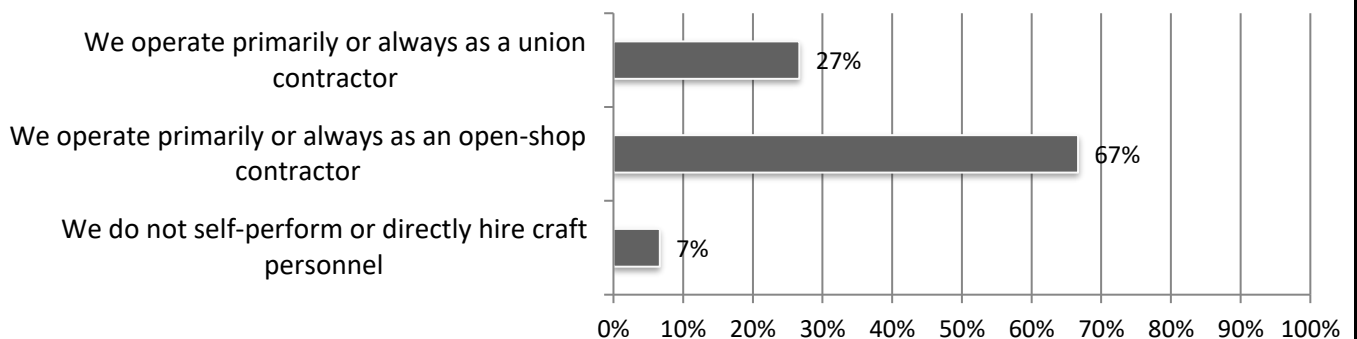

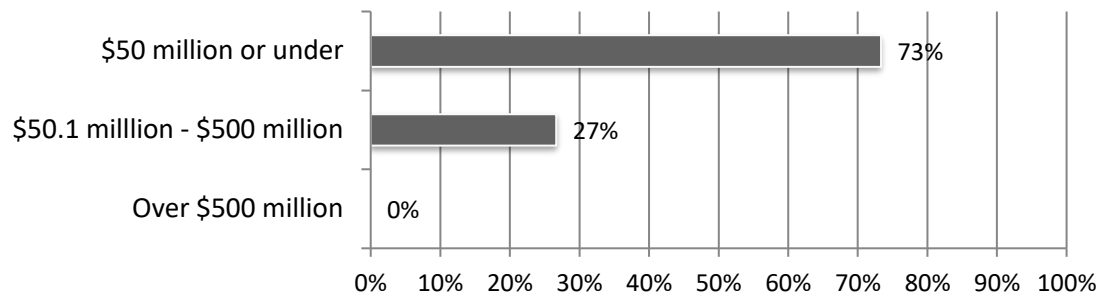


**18. When you self-perform construction work, do you operate as a union contractor or an open-shop contractor?**
