




### 2025 Construction Outlook Texas Survey Results








## 8. Did an owner postpone or cancel any projects that were scheduled to start in 2024 or 2025? (mark all that apply) Responses: 88




#### 9. If projects were postponed or canceled, what was the main reason? (mark all that apply) Responses: 74








#### 14. What are your biggest IT challenges (mark all that apply)? Responses: 90









### 16. Does your firm use cloud-hosted technology in any of the following ways (mark all that apply)? Responses: 86




